MANAGING COMMITTEE REPORT

Progress and consolidation often come at different times. We believe that we achieved both in the 1970 season.

Grading:

First, the progress. At last this Association has an official, explicit, and carefully-designed system of grading. This benefits an Association with international and interstate responsibilities. We do not claim that the system is perfect. We know circumstances will change. But we are now tackling our main job seriously - that is, to evolve expert referees and known standards. We are trying systematically to appoint members to games in a rational, predictable order of quality. That is the real justification for an independent Referees' Association. Anybody at all can "appoint" in haphazard fashion. Our members have cooperated in the grading scheme splendidly. As often happens, a vital change proved easier than many suggested.

Of course, being a team system, it cannot always coincide with every individual interest. It does sharpen lines of advancement. After the changeover period, that offers at least as many satisfactions as temporary disappointments. From 1971 season onwards, there will be a real basis of comparison for every member. It is unhelpful to relate 1970 appointments to the relative non-system of previous years.

Grading in Action:

Broadly there are three classes of referees for "A", "B" and "C" class games. The classification of games is partly laid down by the scheme, and partly left to the judgment of the Appointments Board. The classification of referees is entirely a matter for the Appointments Board, independent of the Managing Committee. Among the relatively few "nonflexible" appointments are first-grade senior games (as above), and the top three G.P.S. 1st XV matches per week. In the interest of players, the scheme aims to give such games unquestioned status. First-grade status is now given with special care. Our aim is that here - as in Sydney - all "grade" and like appointments will be highly regarded. The recruitment picture (see below) suggests that we are already approaching this position.

"Flexibility" Built In:

The grading plan provides for the better lower-grade etc. matches to move into higher appointment classes as circumstances warrant. This fact, together with better incentives and standards for more junior members, enables us to do a better job for all players, without exaggerated

and wasteful instability of our "first-grade" category. There are "plums" for all grades, not least the G.P.S. 2nd XV matches, which we "took over" again this year after almost ten years' interval.

There are two facts of life beyond the Association's control: there is a marked "taper" in number of games before May and after July. At all times, the amount of really good Rugby (given our still rather negative style) is farily limited. We should adjust to these realities as standards of play keep rising, and the vagaries of pre-grading days are forgotten.

A review of appointment records shows that the "average" member in 1970 did better in terms of number of games, and length of season, than in pregrading days. A pleasing trend.

Significantly, the annual report of the G.P.S. Schools to the Union makes special and favourable mention of our new system.

Interstate Recognition:

The Sydney and N.S.W. Referees' Association have officially agreed to accept our gradings as equivalent to theirs. Our members will enjoy reciprocity according to their status here. This is an important matter of status for the Association as well as individual members. It depends essentially on the grading scheme.

Young Members' Committee:

The Committee was created by the Managing Committee this year. It is meant to give administrative experience, to spread responsibility, and to improve contact between officers and "newer" members. The experiment was undoubtedly a success. After only three months as Chairman, Brian Short became an efficient Secretary to the Association. It is not easy to take over in mid-year at any time, least of all when new things are being attempted. The Committee thanks Brian, and his efficient colleague and Treasurer, Don Jowett.

Main Functions:

We hold an annual lecture in memory of Bill Wyllie, long-term referee and Q.R.R.A., official. Our noteable "capture" as lecturer this year was Charles Blunt, Chairman of the Australian Rugby Union. Mr. Blunt addressed members and visitors on Rugby's "parliament", the International Board. Highly popular was the end-of-season dinner at the Majestic Hotel.

There were more prepared talks at ordinary meetings, many of high quality. Two meetings were devoted to colour-slides and recorded commentary on the Laws of the Game.

On 23rd December, there was a gathering at a city hotel for pre-Christmas drinks. There was a really encouraging attendance. We thank you not only for coming, but for your ready and reliable replies to the invitation.

D.J. Minter Trophy:

This award is in honour of stalwart member, John Minter, lost in a drowning accident in 1963. It is given for "Outstanding Service to Rugby by a Member in Any Year". It is not necessarily given every year. For the first time it went to a country referee - Jim Buckley, President of the Downs Referees, Secretary of the D.R.U., press correspondent, and a Downlands College coach.

Interstate "Exchange":

The interchange of referees for N.S.W. v Queensland games continued. Roger Vanderfield (N.S.W.) came to Brisbane in May. Kevin Crowe ran the match at Eastwood, Sydney in July, Several members assisted the Downs Association with Risdon Cup matches. At the D.R.A's invitation, John Forbes and Bob Douglas handled the Grand Final and Under 19 final at Toowoomba in September.

"External Affairs":

The Association received nothing but courtesy from the President of the Q.R.U., from the Union's Committee, and from Secretary Mr. Ron Hopkins. Our views, expressed where necessary, received the fullest consideration. We thank, too, the clubs, schools, Juniors, and Sub-District Union for their friendly co-operation. As in the past, members were entertained as guest speakers at Rugby Schools, including B.S.H.S., Nudgee, C.E.G.S. and Ashgrove.

The Association is to be represented at the 1971 Convention of the Australian Society at Canberra on 13 - 14 February. A report will be made later.

Recruiting:

At the opening of this Report, we referred to "progress" and "consideration". The vital consolidation was a sharp rise in promising recruits. Grading certainly did not deter them - quite the reverse. As another means of enhancing standards, a one-year "probation" was introduced for the senior badge. Entrants now become "Active Associate" members (eligible for official appointments) and then tackle the senior badge after a whole year's experience. We are confirmed in the view that ballyhoo and "quickie" campaigns are not useful, necessary or desirable as a main method of gaining good recruits.

Of publicity generally, it may be said without criticism of anybody that not every exercise in this field is suitable for the Association. Competence, independence and a sensible degree of detachment are our best contribution to Rugby's true interests. It's no cause for blame or surprise that few passing agitations are seriously concerned with standards of refereeing. Given a healthy Association, it is fair to ask that refereeing concerns and ambitions be pursued through the Association.

Looking Ahead:

Your Committee is firmly of opinion that the principle of grading should be here to stay, and that no retreat could be rationally justified.

Clearly the Young Members' Committee should continue. Our present policy of greater delegation of functions to willing and capable members should likewise continue.

The time is ripe for making all major representative appointments in Queensland "State" decisions of the Q.R.R.A. and Q.R.U. Support of the Q.R.U. is here essential. Given due courtesy and consideration, Country referees can be expected to agree at the present time. Country men are entitled to more contact with us. This will require outside financial support. Our finances are healthy but modest, and can only remain so.

When we have a permanent referees' room and (here's hoping) private shower at Ballymore, some internal decoration would be welcome. This is largely up to us.

The incoming Examinations Board might profitably consider an "objective" written test for the Senior, as well as the other badges.

Should we take on more commitments for touch judges? If recruitments continue to prosper, this might be a point best decided by the younger members. There is also some good Rugby offering in e.g., G.P.S. Under 16's, if suitable arrangements were made with the Schools.

Functions like the pre-Christmas party may well be the right social medium for this day and age. Perhaps the number of General Meetings might be slightly reduced, after mid-season.

There are very real reasons for optimism in 1971.

APPOINTMENTS BOARD

Because of less than usual wastage through transfers and resignations, and a pronounced increase in new membership, the Board was able to cope with increased commitments in the selective fashion demanded by the grading system.

Including visiting referees, who were always most welcome, sixty—three men controlled 855 official appointments. Indicative of the increase in permanent strength is the fact that thirty-eight (38) referees did ten or more matches each. Apart from official appointments, some members were active in sub-junior, school, university and army matches.

EXAMINATIONS BOARD

In 1970 the Board introduced closer control of both examinations and records. A new badge design (maroon upon white) was introduced for Associate members. The Board welcomes the new rule requiring one year's service as an Associate before taking the Senior badge. It now becomes much less likely that our highest badge will go to the most casual and temporary recruits.

An "objective" written test was introduced for Associate members, and might well extend to the theory side of the senior badge. It saves embarrassment and produces even standards. Of course written tests call for more careful control. We are confident that the Association has advanced to the stage where more specialised examining is both desirable and feasible. Dates for exams might also be put on a more formal basis.

YOUNG MEMBERS' COMMITTEE

During the year 1970 for the first time in the history of the association, a Young Members Committee was formed. It had become apparent during previous recent years that there had been a large influx of new members. It was considered by the committee of the association that some nucleus should be formed which would give these younger members direct access to the general committee.

The original members of the Young Members Committee were Brian Short as President, Pat Spranklin and myself. However when Brian took over the position as Secretary of the association I became President of the Young Members Committee and Col. Waldron was co-opted to the Young Members Committee.

A number of meetings were held during the year and even though it appears that not much was achieved in the year it became apparent that there is a need for a Young Members Committee.

One of the duties delegated to the Young Members Committee was to seek out a scheme of perpetuating the memory and exploits of former members who have achieved distinction, and other members whom it is considered should have their memory and their achievements preserved. It was considered that an Honour Board was the best means of providing this, so for this purpose Col. Waldron was sent upon a scavenging expedition at the Brisbane Grammar School and in due course produced two Honour Boards which when they are stripped and painted, will provide an excellent addition to the walls of the dressing room. I would like on behalf of all members to thank Col. for his good work.

As you all know it was proposed that a get together be held for the new members of the association under the auspices of my committee towards the end of the last season. This plan was approved by the committee of the association. However, was considered in that the best time for such a gathering would be relatively early next season due to the number of functions which are held and which are traditionally held towards the end of each season.

It is hoped that the Young Members Committee will continue to exist and will prove a conduit pipe between the committee of the association and newer and younger members so that they may feel at home within the association.

COUNTRY ASSOCIATIONS

Referees' Associations are firmly established at Townsville and on the Darling Downs. Each is affiliated to the State body. President of the Downs body is Jim Buckley, winner of this year's Minter prize, and also Secretary of the Downs Union.

The State senior badge remains the principal qualification for country members. This pattern will probably continue, as it has for many years in New South Wales country zones, particularly as more important appointments become "State appointments". However, Townsville has a local badge, and the Downs is likely to have one in 1971.

A Central Queensland Association will affiliate this year. Secretary Greg Beeston writes from Rockhampton:

"There are four senior members in Rockhampton - Paul Braddy, John White, Terry Moore and myself. A Number of unqualified people do the junior games, but it is hoped that these people will qualify for their Associate badge in 1971.

The number of games controlled each weekend is three senior, and up to five junior games. Junior games will increase in 1971 when it is hoped to have a school competition. Both the standard and the number of referees will have to be improved. We hope that this will come about with the advent of an affiliated Association and regular meetings, possibly with guest lecturers."

The President had informal correspondence with referees in Cairns and New Guinea during the year.

REPORT ON THE A.S.R.R. AND AUSTRALIAN LAWS COMMITTEE A.S.R.R.

The activities of the Australian Society of Rugby Referees for the season 1970 centered around a Laws Convention in Melbourne on February 14th and the circularising of the law corrections from I.R.B. meeting held in March 1970.

The meeting in Melbourne was successful although there was a small attendance. The previous convention was also held in Melbourne which may have taken some of the interest away from the 1970 proceedings. Due to time and personal commitments, I was unable to attend this convention and Joe Gilbert, former Queensland player now Melbourne Referee agreed to stand in as my proxy.

The main points coming out of the convention were formation of more active social committee and offer more assistance to the A.R.U. and the various States on the question of law and law changes and suggestions.

The social committee got away to a good start with a President's at Home which was attended by Mr. and Mrs. Charles Blunt and raised some \$100 towards future expenses of the Society.

As this report is being published several of your members will be attending the 1971 convention in Canberra and for the first time financial assistance towards fares is being given by the society. I will report further on this after the convention.

The full activities of the society in 1970 are available in a newsletter; three or four of these newsletters will be published during the coming season.

AUSTRALIAN LAWS COMMITTEE

The first Laws Committee Meeting was held in Sydney on Sunday, July 12th. The meeting dealt with problems arising out of law changes made during I.R.B. Meeting which is held at the commencement of our season and the difficulties in having the draft prepared in time. The Chairman of the Laws Committee, Dr. I.R. Vanderfield did a splendid job in getting these changes to the various states before the conclusion of the first round. The A.S.R.R. committee played a very important part in the drafting of the law changes. Two suggestions by Australia were submitted:

- 1. Adoption of the 25 yard dispensation ACCEPTED
- 2. Revision of the "knock on" law (aerial knock-on) RESUBMITTED TO 1971 MEETING

There will be further matters considered at the next law committee meeting to be held in Canberra on 14 February. These considerations will be reported back to you along with the outcome of the A.S.R.R. Meeting.
