PRESIDENT'S REPORT 1974

LAWS COMMITTEE

The Laws Committee had a meeting late last year to review the introduction of the new Lineout Laws and their application during the English season. Most reports indicate the lineout law worked well with the English referees being severe on gap and encroachment penalties.

Discussions on the maul ruck laws were highlighted following complaints by Wallaby management and players, that binding and blocking infringements were prevalent throughout the tour.

Brief discussions were held late in the season to review law remits and changes are to go to the I.R.B. meeting early next season — more on this will be reported early next year.

APPOINTMENTS BOARD REPORT

For some years the Association has had the practical choice between selecting the Appointments Board from a limited number of non-active members or, alternatively, treating its most senior active members as eligible for the Board. In 1974, the Management Committee firmly opted for the latter choice. We trust that its confidence has been amply rewarded, even in the short space of one season.

For the first time a properly organised grading system was initiated and used. It is felt that this is a service to the members rather than an imposition. It required the Board to make sound and well reasoned value-judgements based on a continuous process of watching the members in action. The results of the sightings were formulated into written reports which were passed on to the members. By mid-season all active members had received notification of their grading. Seventy such reports had been issued by the end of the season.

Statistics

To a large extent, the statistics appended to this report indicate the Boards policies, and the progress of members. Of course, illness, unavailability and the demands of other games did not always allow the Board to make its ideal choice. These statistics have been greatly expanded this season. It is felt that members will wish to receive a more comprehensive study than has been heretofore published. Touch judge appointments have been included in the grand totals for the first time, so that the efforts of the less highly graded members who have given yeoman service may be properly appreciated. Doug Finlay is to be congratulated on taking 40 appointments in his first season back from the country. Doubtless Graham Sheehan's total would have been much larger, had he not unluckily broken his ankle in mid-season.

No one who studies the statistic and then reflects upon the season just past need ever doubt that an efficient grading system does stabilise the appointments and give due regard to those ready for advancement.

Policy for the appointment to Final Matches

Considering the size of our membership, appointments to the semi-final and final stages of the season show a reasonable spread of honours. The Board stand firm on its policy of selective approach to appointments in the final stages of the first division competition. It is considered only fair to the players, the supporters and to the referees that we appoint members of proven average ability to control these games. It will be policy of the Board to continue to appoint to the Finals and Grand Finals strictly on quality of performance pertaining at the time,

and abandon the idea that these matches should be apportioned between members. Kevin Crowe is probably, the first member to take the semi-final, final and grand final in First Grade. Bob Burnett and Doug Finlay by virtue of outstanding displays were appointed to successive finals in reserve and third grade.

Major Appointments and Promotions

The Board sincerely congratulates Bob Burnett, Kevin Crowe and Marcus McManus upon their several appointments to major representative matches. To Colin Waldron on his confirmed promotion to first grade and to Colin Stubbings and Douglas Finlay, who fully justified the Boards confidence in introducing them to first grade fixtures. All members promoted were counselled by the Board as they progressed and a proper interest shown in their performance and ability.

Country Referees

Bearing in mind the Board's duty to our Counttry members, every effort was made to appoint these members to appropriate games in the City.

The appointments were made on the same basis as those of any other member of the Association. The Board appreciates the generous reception given to country members by those in the city. The outcome was a resounding success and resulted in Marcus McManus and Jim Buckley officiating at a number of First grade matches. Marcus is also the first country member to be appointed to two major representative matches by the State Appointments Board who are choosing from all Queensland referees. So long as the Association remains responsible for country referees it will be their policy to continue to encourage and appoint to city matches all country members according to their merit.

This Board, if given the opportunity, is willing to continue the work begun in 1974. It considers that a Board of three bona fide working members is ideal for harmonious and efficient appointing in this Association at the present time.

Finally, the keen interest, generous support and willing cooperation of all the members has been of considerable help to the Board throughout the season. In particular the willingness of all members to accept last minute adjustments, additions and cancellations was much appreciated. It is to be hoped that such emergency measures will be at a minimum next season.

EXAMINATIONS BOARD REPORT for the 1973-74 EXECUTIVE YEAR

A total of six (6) new members were examined, field-tested by the Appointments Board and subsequently admitted to full membership this year. They are Messrs. N. Daykin, S. Skala, D. Richards, D. Procopis, P. Doilibi and W. Smith, all of whom attained a high standard in their examinations.

Potential new members who have contacted the Association but have not yet undertaken an examination are Messrs. J. Lucy, P. Tully, W. Green and M. Grant-Taylor. They are urged to do so before the 1975 season commences.

The number of new and potential members is most encouraging and will greatly assist the Association in meeting its commitments in the 1975 and subsequent seasons.

Transfers from other associations this year were Dr. Bill Pattie (Sydney), A. Hein (New Guinea), D. Simpkins (Adelaide), and M. De Silva (Ceylon). These members are most welcome to our Association.

The benefits of the Junior Referees Association established three years ago, were realized this year, when the Management Committee decided that Junior members could transfer automatically to the Senior Association provided they passed a field test. John Barber was the first such member to avail himself of this decision. The age limit for such transfers will be at the descretion of the Management Committee and each case will be considered on its merits.

As in previous years, a team of experienced referees made themselves available to lecture at schools and prepare candidates for examination for associate membership. The Board wishes to thank all the members concerned.

In an effort to formalize Associate membership, with a view to improving the refereeing standard in schools and country areas, the Board submitted a detailed proposal to the Management Committee in July this year. Highlights of the proposal were that examination for Associate membership be conducted by the Q.R.R.A. Examination Board; that Associate members be registered with the Association and be required to pay a fee thereto each year; and that an Associate membership register be made available to School Sports Masters to assist with refereeing appointments on their "at home" match days. In return for registration, the interests of Associate members would be looked after by a sub-committee of the Q.R.R.A. which would feed back information on law changes and arrange lectures and films.

To date there has been no response from the T.A.S. Sports Association nor the G.P.S. Sports Association but it is understood that our proposal is being considered and replies should be forthcoming early next year.

In conclusion, it is the Board's hope that members will continue to do their best to recruit new members for the 1975 season and thus ensure the continuance of the Association.

The "Meet the Wallabies" night held in conjunction with the General Meeting on 13.3.74 was a great success. A panel consisting of Wallabies David L'Estrange, Mick Freney, Dick Cocks (deputising for Jeff MacLean) and coach Bob Templeton with Chairman Kev Crowe were asked questions by the Association members. The theme of the discussion dealt with impressions gained during the recent Wallaby tour of the U.K., France and Italy in relation to application of the new laws by overseas players and also referees' interpretations thereof. The standard of refereeing generally and variations in interpretation by overseas referees were also discussed.
