#### PRESIDENT'S REPORT 1981

The Association in 1981 has tried to continue a program of innovation commenced during 1980. Not all projects have been completely successful but feedback received indicates we are heading in the right direction.

Our season commenced earlier than usual as the Australian Society of Rugby Referees held a 2 day seminar at The Southport School in late January. The seminar was sponsored by TNT and attended by referees from Townsville to Lismore. Certificates were awarded for those who passed the examination and the President of the Australian Society Kevin McGregor has advised that a 1 day seminar will be again held, in Brisbane this time in February/March, 1982.

The Australian Society's Annual Meeting was held in February with Kevin Crowe elected to the Management Committee. The Society plans constitutional change to be promulgated at the Annual Meeting and Convention in Adelaide in February, 1982.

This Association has also been involved in coaching and a coaching weekend with Kevin Crowe and myself was conducted in Rockhampton and visits were made to other Country centres. Kevin Crowe handled the Wide Bay Grand Final and our referees also officiated in Townsville, Kingaroy, Gympie, Gold Coast, Maroochydore with Chris Oxenford participating in the Country Carnival at Mackay. Hopefully we can spread our wings further in 1982.

All interchanges were highly successful and from correspondence received will continue next year. It was pleasing also to be able to provide games for visiting referees from New Zealand and various Queensland Country Centres.

No doubt the visit of Alun Richards (Wales) and Graeme Harrison (New Zealand) as independent referees for the Tests against France was a major highlight of the Season. The goodwill created and the knowledge imparted was of great benefit to everyone. It must be the aim of this Association to produce a Queensland Referee to obtain similar status overseas.

Col Waldron and Kerry Fitzgerald were once again selected on the Australian Representative Panel. Kerry made his debut in the game France v. Queensland Country. Col came very close to obtaining a Test Match in New Zealand. We want to further improve our representation on this panel next year. Major Queensland matches were controlled by Col Waldron, Kerry Fitzgerald, Cris Oxenford and Tony Duffy. Queensland B and minor representative matches were shared.

The season saw the retirement of Bob Burnett from representative matches. To mark his contribution to Rugby a dinner, hosted by this Association, the Queensland Rugby Union and in the presence of the Governor, was held. Attended by over 100 on a black tie basis the evening was a huge success and thoroughly enjoyed by Bob.

As in every year there are some disappointments. The draw of matches in the first half of the season was punctuated by split rounds and numerous byes. A regular complaint was that there was little continuity of games and good games were few and far between. We also endeavoured to institute a system of reports on referees by clubs. However some clubs did not report. The more information we receive on referees the better we are placed in locating weakness and providing help. The association should pursue the system again in 1982.

On some occasions members were required to double-up for games and particularly during the school season we were stretched to the limits. The Junior Association at times provided relief. There were reasons for the shortage, injuries, business trips, change of school holidays and so on. It is clear that 1982 will need to be a recruiting year so that we can maintain our strength and meet our obligations.

To balance the disappointments there is the real possibility of negotiating a substantial sponsorship and a renewed enthusiasm to have our own clubrooms at Ballymore.

I would like to thank all members who assisted in ushering, selling doubles, billeting interchange referees, entertaining visitors and generally helping out when asked. There is a growing list of those who are prepared to do their "bit". My committee seemed to expand as the season went on. Alby Taylor, Col Waldron, Kerry Fitzgerald, Chris Oxenford, Cec Menzies, Greg Howard and Richard Bendeich worked hard. The various committees from Appointments Board to Judiciary did their job. Thank you all for your efforts.

Finally to the Q.R.U. and all affiliated clubs and bodies, thank you for your support and hospitality and we look forward to assisting again in 1982, the Queensland Rugby Union's Centenary Year.

#### TREASURER'S REPORT

I would like to thank all members for their efforts in fund raising. With the generous help from the Queensland Rugby Union in contributing \$1000.00 to our exchanges from the Development Fund, we have been able to cover expected expenses. I would like to express the Association's appreciation for such a valuable grant.

Greg Howard in his first year as Assistant Treasurer, has been magnificent in his enthusiasm for fund raising efforts. His highly successful organisation of the major raffle ensured a healthy financial situation for the year. Also he has been given great help by Richard Bendeich, our professional doubles seller.

Our main expenditure was a substantial subsidy of the Annual Dinner including the presentation of trophies, and the hosting of the visiting International Referees. We have one outstanding account of \$500.00 for the Lapel Badges.

The expected income from usher duties and possibly from sponsorship, may improve the financial situation for 1982. It will certainly be needed if we plan to construct club rooms.

#### AUSTRALIAN SOCIETY OF RUGBY REFEREES REPORT

Two meetings of the Society were held this year. The first on 19th February was to coincide with the arrangement for the National Coaching Seminars for Referees held in all capital cities during 1981. For those who attended it is no surprise that they were a great success. Feed back from the seminars held in conjunction with the National Coaching body was that these particular seminars were perhaps a little too intensified. The success of these seminars was largely due to the efforts of the sub-committee appointed, and the President's involvement in arranging sponsorship through T.N.T. which carried the financial burden away from the individual.

This sponsorship also has allowed the Society to plan for a more constructive convention for the future, which has now become a bi-annual event. The 1982 Convention will be held in Adelaide on 27th - 28th February with the Annual General Meeting on Friday, 26th February. Arrangements are underway to invite Tom Dooley, the New Zealand referee (who incidently attended the Welsh Convention early in 1981) as guest speaker. This convention also will coincide with a Coaching Convention organised by the South Australian Rugby Union (but quite separate) in which a prominent New Zealand Rugby coach will be present. The Society will also invite this coach to speak to the Convention.

The Referees Development Program will continue through 1982 with emphasis on one day seminars, more intensified on refereeing problems and education rather than combined efforts experienced in 1981. These seminars will spill over into country areas again backing up last year's program.

The 12th July Meeting confirmed guide lines laid down on 19th February Meeting with modification to such programs as development, conventions etc. General Business raised that Society Blazers were available to referees who had refereed international touring teams. These blazers would be the National green with the Society pocket.

The Society had a very busy year and a lot of thanks must go to Rod Nicolle for his efforts when one looks at the distribution of some 2,400 Law Books, 400 PLay the Whistles, and 1500 Newsletters, one wonders who he works for. Also his efforts plus sponsorship have made the Society a viable body. As the Financial Report shows the Society now has surplus funds, it can invest for the future.

Several proposed law changes were discussed, the main point being the Australian proposal to the International Board that half backs not be allowed to advance beyond the centre line of the scrumage until the ball is out. Dr Vanderfield, our representative, will be placing this motion at the next International meeting in March, 1982.

Any proposed law changes must be submitted to the committee by December and the Queensland Rugby Union Referees Association will be well advised early in their 1982 season to discuss freely with members their thoughts on proposed law changes to allow your representative ample time to support their proposal.

#### LECTURES COMMITTEE REPORT

Meetings for the year commenced in March and concluded in February. In the absence of any changes to the Law, lectures were mainly directed towards clearing up interpretations and attempting to consolidate a uniformity in refereeing aspects of the law.

To this end, lectures were provided by many of our members from all sections of the Association.

Supplementing these lectures were talks from Mike Thomas, Coach of Easts, Terry Doyle, Secretary of the Q.R.U., David Clark, Queensland Coaching Director and Dr Peter Myers, the Q.R.U. resident ground doctor. Our thanks to all of them for taking the time to speak to us.

Next season will see the implementation of new laws in relation to the "tackled" ball and scrum binding. A comprehensive lecture programme will need to be undertaken to ensure that there is uniformity within the Association.

#### EXAMINATION BOARD REPORT

As in seasons passed, the 1981 season saw only a handful of new referees (six) examined for Senior Membership. On the other hand it was pleasing to see the number of new Country referees.

Associate Lovel Examinations were conducted for B.B.C., Gregory Terrace and B.G.S. The G.P.S. Schools have now struck their own badge and they will require our consultative assistance in the future.

Continuing work was done on upgrading the Examination paper to cater with new laws and modern trends in Rugby.

Our number of active referees is stagnating and a major effort must be made to improve this situation.

I would like to thank Graham Colditz and Barry Leask (who replaced Marcus McManers) for their help on the Board this season. I would like to express the Board's appreciation for the support given by Ian Scotney and his Management Committee during the season.

#### GRADES COMMITTEE REPORT

This year the Grades Committee meet every second Wednesday at HQ under the Chairmanship of Mr John Breen. Once again the spirit of co-operation was good despite the obvious frustration of most of the Clubs at the "split-round" situation. Certainly the club competition should prove more consistent and workable next year (from a referee's viewpoint as well) when three full competition rounds will be played leaving one bye per club per round.

Criticism of referees was minimal at the Grades Meetings indicating a definite improvement in refereeing and consistency of refereeing right through the Grades in 1981. However, it was disappointing to find that the clubs were not using the facility provided on the team card to report on the referee. It is hoped that next year the clubs will take a greater interest in this opportunity to comment on referees.

#### PUBLICITY REPORT

After liaison with the Management Committee, a number of objectives were formulated for publicising the Queensland Rugby Referees Association. The objectives were, as detailed below:

- 1. To publicise the Rugby Referees Association and its activities.
- 2. To attract new members to the Association.
- 3. To promote a greater understanding of the Laws.
- 4. Attempt to catalise thoughts and attitudes regarding the Queensland Rugby Union and the Football Competition in general.
- 5. Create a regular article in 'Rugby 81' which spectators, players, coaches and referees would want to read.
- 6. To promote greater Club liaison with referees.

These objectives were achieved through twenty-two articles in 'Rugby 81', attending six Club Meetings as a representative of the Q.R.R.A., and issuing five Media Releases. The major success of the season was acquiring two new referees from this program. Other notable happenings include the first ever Pen Pictures of referees, maintaining Law Questions in the Rugby Program, an attempt to trace historical aspects and development of the game of Rugby Football, and publishing outspoken articles regarding referees and their hitherto neglected position in Queensland Rugby.

Apart from publicity, promotion of our Association will become increasingly important as the code of Rugby Football develops and grows in Brisbane. I believe that the Referees Association has to grow with the game, and that means money and sponsorship for its promotion. The Queensland Rugby Union's sponsorships certainly promote the game of Rugby effectively and we will see more teams and players participating in the future. It will become increasingly difficult to play the game competitively without referees. Unless something is done quickly, the referees will be left behind and Rugby in Queensland will inevitably suffer.

The greatest stumbling block I found with publicity this year, was that it is only one tool used for promotion. It was essential to keep in close contact with the Management Committee so that our aims were compatable. To me, it would make common sense for the two Committee Members to takeover and share responsibility for total promotion of the Association. This promotion should centre around:

- 1. Outward promotion within Clubs, providing our services and establishing a definite image (attend Club Meetings, provide Lectures and recruit new members).
- 2. Maintain our image by continuing publicity.
- 3. Provide direction as well as adequate promotion and progression within the referees Association (a greater acknowledgement of new referees is needed to encourage them to 'stick it out').

I would like to thank Messrs Peter Gates, Viv Boland, Ron Nichol and Phil Jones for Literature, articles and ideas, John Dedrich for inclusion in the Test Program, Gary Taylor for fulfilling photographic requirements, Messrs Alan Taylor, Colin Waldron, Ian Scotney, Kerry Fitzgerald and Ashley Broad for helping with articles, the Management Committee for providing information and material which enabled me to meet deadlines and lastly, I would like to thank the Association for the opportunity to undertake this important task.

#### "BOB BURNETT'S BUNFIGHT"

The Testimonial Dinner to honour the contribution to Rugby Football of Robert Thomas Burnett was an Australian Rugby First. It was the first time anyone's contribution to Rugby Football had been publicly acknowledged. As a member of the Australian Laws Committee, Queensland Rugby Union Representative Appointments Board, Vice-President of the Queensland Rugby Union Club, Past-President, Life Member, and long time committee member of the Queensland Rugby Referees Association, Foundation force of the Queensland Junior Referees Association, and the Queensland Schools Union, referee for over 25 years as well as being a five time test referee, it is more than fitting that Bob Burnett be given a Testimonial Dinner.

Mr Joe Gibson and Mr Ian Scotney hosted over 100 guests. The Governor of Queensland, Sir James Ramsay, made two presentations to Bob, a painting and a becoming self portrait photograph.
