#### PRESIDENT'S REPORT

What an interesting year 1989 turned out to be. Our rugby started in February when we were invited by the Illawarra Assoc. to the KIAMA 7's We were represented by Barry, David and Andrew, who in spite of the rigours of the trip, must have aquitted themselves well, because we have been invited back again next year.

We were very fortunate to start the the year with a substantial financial sponsorship from HASTINGS DEERING and we are most grateful to Bill Horsley and his company for this. Our new enterprising secretary David True was the main generating force behind this sponsorship and we thank David for his efforts.

The Lions were coming and the representative calendar held a lot of promise. We saw some enterprising rugby in the South Pacific Championships with our referees, Col, Bernie and Barry aquitting themselves well. Our second grade panel also set a fine standard in their appointments to the new Winfield State Challenge Series.

Kerry Fitzgerald returned from overseas having controlled a spectacular Scotland v. Ireland clash and then a climactic Wales v. England match. We were all saddened early in the year by the sudden loss of Kerry's mother and our sincere sympathy goes to Kerry and his family. We will always carry fond memories of Ronnie in our hearts.

For the first time we had five referees accepted on the Australian panel and they received a record number of appointments, of particular note was Mark Powell's appointment to a Lions game in his first year on the panel and Kerry's appointment to the historic Anzacs v. Lions match. Another first was Col's appointment to the Singapore Sevens.

One of the great successes of our new system of coaching was to see our senior graded referees putting so much effort into developing the skills of other referees. It is important that their knowledge of the modern game is passed on and this will improve the game at all levels.

Our new classification committee was kept busy under the guidance of the chairman lan Scotney, operating under the select committee findings of restricted numbers in grades with promotion/relegation to apply. This season we also invited all clubs to report on all referees performances.

The new appointments officer Peter Galloway settled quickly into his job and this year he was given an assistant to ease the workload and this was our Registrar Paul Dempsey – both of these members are to be congratulated for their work this season.

Our social calendar started early with our inaugural Golf Day/Dinner at Indooroopilly, and this event proved to be a resounding success both as a social occasion and a fund raising venture. We greatly appreciate the support of all our sponsors and of particular note was the

support from the GPS Schools. The dinner was a great highlight with Peter Mears as MC and John Breen as a very interesting and entertaining guest speaker. We thank them for their contributions. The efforts of Kim Buchanan and his sub-committee in organising and staging this event cannot go unmentioned.

Recruiting of new members has been good but in the first half of the season there were many more referees than regular games. This year we agreed with the GPS Schools to appoint to all "A" games plus touch-judges to 1st XV games and this gave more of our members a great opportunity to referee school boy football.

We welcomed Queensland country referees to Brisbane games this year for classification and as part of our development programme, awarded a Queensland strip to all country referees who were appointed to games by the QRU Rep Appointments Committee. All reports indicate that this gesture has been well received and should be continued.

This season all Queensland Country Referee Associations became affiliated with our Association and we hope to develop closer ties in the future as their go-between to the ASRR.

Congratulations to all referees selected for interchanges, Andrew Cole and Mike Carmody to Sydney, Scott Young to ACT, Tony Mellick to Hamilton and Joe Carter to Canterbury. All returned with glowing reports of their exploits. We also had a number of referees visit Northern Rivers, NSW by invitation to assist in that association's development. I thank ANZ for their very generous support of our interchange programme, and Tony Mellick for initiating this support and only hope that it will continue in the future.

We welcomed our interchanged referees to co-incide with the 2nd Aust. v. Lions at Ballymore plus the mid-season social event held at the Queensland Arms Hotel, and what a great night it was. We hosted referees from Sydney, ACT, Illawarra, Northern Rivers, Hamilton and Canterbury plus the Test referee Rene Hourquet and his NZ touch judges. Rene sure sings a good Marseillaise.

I would like to thank all those members and their families who assisted with billets and hosting our visitors, a special mention to Peter Weingott for his effort in organising all billeting arrangements.

I take this opportunity to congratulate all referees and touch judges who were appointed to grand finals this year. Very good accolades have been received from all clubs concerned in these games.

To cap off a great year, Kerry Fitzgerald was appointed to control the two Springboks v. World XV Tests in South Africa which now must make him one of the most travelled referees ever. From all reports he continued to enhance his already high standards. Well done Kerry.

One of the more disturbing aspects of the game this year has been the increase in kicking incidents, relating to players on the ground. Violence has always been an unwanted but ever present part of our game, but this latest trend has been evident in games at all levels, from the highest grade of international through to the lower grades of club football. Only strong consistent action by both referees and club officials, backed by an unbending judiciary system, will rid the game of this blight.

Our end of season Social and Presentation Night was held this year at Lennons with a mixed function and has been described by most who attended as absolutely delightful. Congratulations go to the recipients of the major awards, Kim Buchanan received the John Minter Award, Tony Dunne received the Murray McNae Award as the Most Improved Referee, and Paul Dempsey as the Most Valuable Member.

As I said earlier, this has been a most interesting year, at one stage we could have moved to Festival Hall, or the Supreme Court, but we overcame all difficulties. I wish to thank all of my executive members, Col Waldron, David True, Joe Carter, Mick Eastwood, Kim Buchanan and Peter Weingott for their support

during the season and in particular the difficult times when we became involved in constitutional matters.

I have been assured from all sources that the standard of refereeing in this association has never been higher and a lot of the credit for this must go to our new classification/coaching system and the efforts of lan Scotney and all of the first grade referees. A lot of credit also to the quiet man behind the scenes, Barry O'Connor and his sub-committee training new members.

I have enjoyed my year as your President and I can only hope that you have enjoyed your rugby as much as I have.

#### TREASURER'S REPORT

The association produced a profit of \$18,467.97 (\$2,551.98 – 1988) from a turnover of \$33,758.50 (\$23,363.74 – 1988).

This profit was due to an increase in sponsorship, interest and our most successful golf day combined with a 25% decrease in payments. The profit for the year can be considered a most satisfactory result.

Financial membership increased by five (5) over 1988 as demonstrated below.

There is currently debtors outstanding of \$313.00.

#### AUSTRALIAN SOCIETY OF RUGBY REFEREES

The main role of the Society is to maintain the high standard of Australian refereeing and to improve on the levels already achieved.

To this end we have developed a number of projects.

Referees from States other than NSW, Queensland and ACT who show potential of achieving representative level are given games in the major states to allow them to be seen and coached. This year a referee from Perth was brought to Brisbane. This will continue in future years.

The Society is currently finalising its policy on overseas exchanges and we will be sending a referee overseas on a reglar basis. The referee obviously must show potential of being International Representative standard.

In February the second advanced referees seminar will be held and nominations will be called from all states. There will be strict selection criteria for participation.

In 1990 the Society newsletter will be available to all members by subscription and referees will be informed of the mechanics early in the new year.

#### JUDICIARY MEMBERS REPORT 1989

The Jidiciary met on 20 occasions during the season to deal with 32 reports on players dismissed from the field of play.

The number of send-offs were in stark contrast to the 1988 figure of 47 players reported.

Of particular concern to the Committee in this season was the number of incidents involving kicking or trampling on an opponent. In all 11 players were reported for this offence.

The penalties given by the Judiciary are as follows:

Season -1; 7 weeks -1; 6 weeks -7; 5 weeks -2; 3 weeks 4; 2 weeks -6;

1 week - 8; Caution - 1.

2 players who abused referees did not appear.

I have now served on this Committee for seven years. Member P. McElean for four years and S. M. Garvey for three years. Collectively in the last three years we have heard 133 send-off reports. It is still amazing to hear what some people would like us to believe. However I do foreshadow changes that will be necessary for the sake of the code in conduct of Judiciary and Appeal Hearings.

The 1989 Committee feels that it exercised the directives of the A.R.F.U., in respect of its findings of players guilty of offences and was consistent in its suspension of players throughout the season.

#### Written Reports Received 116

#### Number of Referees who Received Reports

55 (includes visiting referees)
Numerous referees were sighted but no reports issued.

This year the committee operated under a new format. There were fewer members on the committee. Concentration was only on games under our jurisdiction. The panel of 1st Grade referees assisted in the sightings of referees. A promotion and relegation system was introduced. The 1st Grade panel of referees was reduced to 8 in number.

#### **AFRU Appointments**

The committee had its input into Queensland's representatives on the panel. We were successful in obtaining five positions and our congratulations were passed on to Kerry Fitzgerald, Col Waldron, Mark Powell, Bernie Fenberg and Barry Leask. They were subsequently appointed as the AFRU Selection Committee saw fit and all acquited themselves very well.

#### **QRU Appointments**

The appointments board met at least half-a-dozen occasions and a wide range of Queensland referees were appointed to all games. Country referees received their highest level of appointments for many years.

#### Country Referee Developments

Under QRU Coaching Director Kev Crowe, a Steering Committee was implemented to assist country referees. This has proved successful and allowed the QRRA Classification Committee to spend more time on domestic matters. We wish this group well in their endeavours.

#### Interchanges

It is always a delight to have visiting referees and 1989 was no exception. However I wish to sound a warning note here. Ths year we had more than I have ever seen and for a three week period late in the season local referees suffered greatly as all resources (i.e. games, watchers etc.) were needed to adequately provide for the visitors. This facet of our yearly operation will need to be closely watched so our members do not become disadvantaged.

#### Grand Final Appointments

Always difficult but decisions were unanimous. Congratulations to Barry Leask on his 1st Grade Frand Final appointment. We

were delighted with the efforts, contenders for these appointments, made. Competition is always extremely healthy.

#### First Grade Panel

There was some controversy on our reduction of panel numbers to eight. I believe the policy is correct and a much more even performance from referees flowed through 1st Grade and subsequently all grades. I strongly recommend to the incoming committee that this policy continue.

#### Promotion and Relegation

Another controversial issue – the policy was used sparingly this year. Guidelines need to be firmed up so that all members are clearly aware of performance standards required.

#### Peformance Standards

Having been away from the Association for some five years, I believe the overall standard of our referees is much higher than when I left. It is still however highly erratic. It never ceases to amaze me that when a referee is aware that he is being watched, his perfomance is usually first class, however, if he is unaware that he is being watched, standard can be uneven. I can assure you, the main criteria for promotion is maintaining a consistently high standard of performance. it is our duty to be professional at all times to maintain our reputation and creditability as a unit.

#### Lower Graded and New Referees

They need more help and attention. The system of higher graded referees watching referees in earlier games is not working. My strong recommendation to the new committee is that the first two months of the 1990 season be devoted to assessing, educating and guiding referees graded 3rd grade and below. Many were seen and helped this year, but much more needs to be done if we are to maintain our numbers.

#### General

This year has been a learning experience for me as much as anyone. We see more potential for the future and opportunities for our referees than at any time in the past. The basic plan should continue –

- Know your law
- Work on your man-management skills
- Gain your experience by refereeing whenever possible
- · Attend meetings interchange ideas
- Set goals (achievable)
- · Improve fitness level

Such a course of action should see us well placed to appoint referees to enjoyable games for many years.

#### APPOINTMENT OFFICER'S REPORT

After a reasonably slow start, as to the number of games that were available to appoint to, it became obvious that once the School Competition started, our manpower resources would be severely tested.

This was highlighted by the fact that on one weekend which involved a representative game, 67 individual appointments were made from 64 available referees. Without researching our records too closely this is understood to be a record, together with the number of active referees peaking at 79, and the number of overall appointments and referees allocations for the season exceeding 1800.

Numbers aside, every endeavour was made to appoint members in relation to existing and future grading as equitably as possible so as to maximise their potential, goals and more importantly their enjoyment. I thank members for the quality of their performances and especially those who completed every appointment give to them, including those at short notice.

On top of our normal commitments to the Q.R.U. competition, we were asked on very many occasions to provide referees to competitions such as the Schools Metway Cup, four different Tertiary College Fixtures and many one-off games of varying degrees of skill, generally mid-week and at short notice. Many thanks to the likes of David True, Peter Weingott, Peter Smith and John Dee, plus many others for giving their time most generously.

The workload of the Appointments Officer is becoming more considerable with each passing year, and if the growth of rugby continues, so will our Association and along with it a commitment will need to be made to ease the workload and its inherent responsibilities. To this end a large vote of thanks is extended to Paul Dempsey in acknowledgement of his great assistance and support. His tasks were never going to be easy, especially with the large

number of wet weekends and consequential changes, cancellations and referee pullouts. Thanks Paul, the Association owes you a lot, and you were a great asset. Also thanks to Ballymore's Peggy for her prompt assistance, efficiency and co-operation in getting the draw prepared, typed and mailed on time.

Finally, to those who achieved higher honour in Rep and Grand Final Games, congratulations and without exception on a job well done.
