President's Report 2003

In the past 3 years, the common theme of the President's Report has been change and new challenges. Season 2003 was no exception. The Brisbane competition underwent significant change with the formation of 3 divisions of community rugby, the continuation of the Welsby and Premier Rugby competitions, and the increased growth of junior rugby. Aligned with this is the use of association members in tasks and appointments to the ARU. On some weekends, many senior members of the association would be involved in ARU activities making them unavailable for community rugby in Brisbane. Consequently, there has been serious strain on the association resources. The members must be congratulated for their willingness to ensure the Association continued to provide a high quality service for it's "core business", the Brisbane rugby competitions.

Records indicate that many members have availed themselves of the opportunities to improve their performance. Attendances at training, meeting nights, referee coaches meetings and pre-season camp have been high. We have more referee coaches writing more coaching reports. We have more referees appointed to national championships and other representative fixtures. This indicates that the refereeing team in Brisbane not only continues to provide a high level of officiating, but is improving and developing their refereeing skills.

Another challenge this year has been the Management Committee itself. For 2003 it comprised a new President, Vice-President, Treasurer, and three new committee members. It has been a steep learning curve for all committee members. The Management Committee is indebted to Peter Gofton, the immediate past president, for his counsel and guidance. The efforts of our secretary, Tim Matthews, and our treasurer, Peter Backstrom, must be noted. Tim and Peter have set exceptionally high standards for administration of the Association. The QRRA (Brisbane) Inc. has become the benchmark in administration for the other QRU affiliates, and the Association is deeply indebted to Tim and Peter for their efforts.

The Association is in a very healthy financial position. The majority of our income is derived from sponsorship agreements, therefore the Association cannot survive without good sponsors. Hence we are especially indebted to the Queensland Rugby Union Club who has signed a three-year agreement as our major sponsor. This sponsorship enables the Association to continue to be in a sound financial position while providing a high level of service. Of no less importance is the support given by our other sponsors. The referee coaches and training squad were supported by Aretha and Geoff Acton from Dixon Homes, making our referee development team and training squad distinctive in their new apparel. The Coopers Plains Dental Surgery team of George Cocolas, Jonathon Cichero, and Mark Logan has supplied all members with our own association water bottle. Liza Devlin of Paddington Physiotherapy, has supported our referees with professional advice. The Association is indebted to all our sponsors and thanks them for their continuing support.

Throughout 2003 the Queensland Rugby Union has been very supportive of the Association, and I sincerely thank Jeff Miller, Gavin Head and Roger Plastow for their time, advice and expert guidance. Through the Brisbane Rugby Committee, and the Brisbane Junior Rugby Committee, the Association has worked with the clubs in providing match officials for all matches. Special thanks is also given to Cole Barrett, QRU Referee Accreditation and Development Manager, for his help in accreditation and development of our referees at courses and meeting nights. Thanks also to Michael Backstrom, the Referee Administrator, for his assistance with appointments, member correspondence, and the sundry administration matters that crop up day to day.

The achievements of our referees and referee coaches at State, National and International level has reached an all time high. Andrew Cole and Scott Young as referees, and Ian Scotney as an assessor, have been appointed to RWC 2003. Some of our younger referees have been given the chance to grasp development opportunities provided by appointment to National Championships. Congratulations to Ian Smith, Simon Moore and Charles MacGregor on their selection. Congratulations also to Brett Bowden, Greg Hinton, Paul Marks, Geoff Acton, Damien Weston, Michael Tutty, Steve Leszczynski, Michael Jennings, Alistair Mould and Craig Hills, for selection at National Championships and other representative fixtures.

This year the ARU have selected Peter Gofton and Alistair Mould to take part in the Level 3 Referee Coach and Level 3 Referee courses for 2004. These two join a select group of referees and referee

coaches from Queensland who have participated in this year long intensive study of rugby refereeing. Congratulations Peter and Alistair.

The success of our referees is in large part due to the work of the Referee Coaches Group. Terry O'Connor, Referee Coaching Group Coordinator, has developed what is regarded as world's best practice in referee coaching. The mentor-coaching program is regarded as the best way to utilise our coaching resources in developing our referees and referee coaches, and is being adopted by the ACT and Sydney referee associations. Special thanks to Terry and his group of referee coaches for their commitment and energy in improving the refereeing standards of all referees within the Association.

We now have six Level 3 referee coaches in Brisbane, more than any other association. These six are used by the ARU to develop referees and referee coaches of all levels. They are considered to be some of the best referee coaches in Australia and are being used at National Championships, Australian Rugby Shield and other representative fixtures. Congratulations to Terry O'Connor, Frank Meiklejohn, Geoff Pegg, Ian Scotney and Laurie Monaghan for your appointments as coaches at representative level.

Congratulations to all finals referees. By being selected in a finals panel, you have demonstrated your commitment to improving your refereeing performance. In many cases performances in finals provided selection dilemmas for the referee coaches/assessors. Thanks also to the large number of referee coaches that volunteered their time to coach/select during the finals.

Judicial hearings and appeals are a necessary though unfortunate occurrence. Thanks are therefore due to Geoff Gardiner, Tim Matthews, Paul Harding, Chris Newton, John Forbes, Mark Hogan and Marty Chalmers for volunteering their time by representing the Association at these hearings.

This year saw the formation of a special sub-committee to investigate remuneration of referees. The sub-committee consisted of John Forbes (Chairman), Ian Smith, Neil McCann, Marty Chalmers, and Brian O'Donnell. Thanks to this group for its investigation into the issue, and its timely and considered report.

Our Association, despite the achievements of some, could not have functioned as well as it has without the overwhelming support of all members. The dedication and commitment shown by the many has been outstanding. It has allowed the Appointments Board to appoint to in excess of 175 games on some weekends. Thank you all for your hard work. The Appointments Board deserve special recognition for their efforts in ensuring referees are at the games to which we appoint. Thanks to Mark Logan as Chairman, Cole Barrett, Geoff Pegg, Tom Ryan and Brian O'Donnell whose diligence and dedication ensured the appointments process was a success. Well done.

As President, I am indebted to the effort and commitment of the Management Committee. As a rather "inexperienced" committee, they have addressed their allotted tasks with energy and sociability. Stu Tasker, Pat Cranshaw, and Sean Maguire, although new to the Management Committee and the Association, working with "old hand" Bryce Titcume, ensured that the high administrative standards set by previous committees was maintained. Gentlemen thank you for a job well done.

Our Honorary Auditor, Mr. Leon Barrett, and our Honorary Solicitor, Paul Harding, are due our thanks for their time, effort and expert advice on our behalf.

We have already been advised by the QRU that there will be further changes to the administration of rugby in Queensland and to the rugby competitions in Brisbane. We have already shown that we have the ability to accept change and adapt to the challenges any change presents. If, as an association, we continue to show the same dedication and support for rugby refereeing that we have in past years, then the Association will continue to provide a high level of officiating at all levels of rugby in Australia.

Notes to and forming part of the Accounts

1. Summary of Significant Accounting Policies

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Associations Incorporation Act (Qld) 1981. The management committee has determined that the Association is a non-reporting entity and therefore there is no requirement to apply accounting standards and other mandatory professional reporting requirements in the preparation and presentation of these statements.

The statements have been prepared in accordance with the requirements of the Associations Incorporation Act (Qld) 1981. The statements are prepared on a cash basis, whereby items are bought to account as money is paid or received, from the records of the association. The are based on historical costs and do not take into account changing money values or, except where as specifically stated, current valuation of non-current assets.

The accounting policies have been consistently applied, unless otherwise stated. The following is a summary of significant accounting policies adopted by the Queensland Rugby Referees Association (Brisbane) Incorporated in the preparation of the financial statements.

(a) Taxation

As of 1 July 2000, the association was registered with the ATO for GST purposes. It is a non-profit organisation that has voluntarily nominated for GST.

No provision has been made for income tax as the association is exempt from income tax under the provisions of section 23(g) of the Income Tax Assessment Act.

The Association was and still is not required to have a Tax File Number.

The Association collects and pays GST quarterly. A Business Activity Statement (BAS) is submitted to the ATO on a quarterly basis as required by the taxation legislation.

(b) Stock on Hand

All Inventories are measured at the lower of cost or nett realizable value.

Referees apparel is now expensed in the year of purchase.

(c) Equipment

All equipment purchases are expensed in the year of purchase.

For control purposes such items have been listed on the register of non-current assets/chattels.

Appointments Board Report 2003

The Appointment's Board for 2003 was comprised of the following members:

- 7. Michael Backstrom QRU Referee Administrator

The Appointments Board was responsible for referee appointments for rugby matches controlled by the Brisbane Rugby Committee, Brisbane Junior Rugby Union, the GPS, AIC and TAS sports associations. It was not uncommon for the committee to appoint to over 200 rugby fixtures every weekend during the busiest part of the season.

The committee met on 6 occasions during the 2003 rugby season. Referee appointments, analysis of referee coaching reports and assessments ,in-depth discussions regarding nominations for the various carnivals and interchanges that occur each year and selection of referee panels for the various finals' series were the major agenda items at these meetings. As Chairman of the panel, I would like to thank the Referee Coaches Group for their invaluable support during the season.

The current appointment's protocols have been in place for the past 5 years. For the most part, they have remained relatively unchanged. However, the commitments of our association's active members have changed fairly dramatically. With the growth of rugby, many of our members are refereeing 2 or more fixtures every weekend. Through out this season, the Management Committee received numerous pieces of correspondence from members detailing their inability to fulfil all requirements of the current protocol, without potentially jeopardising their respective referee appointments. I would like to state for the record that the Appointment's Board did their best to accommodate members concerns.

Over the last couple of seasons, we have also seen the advent of the Referee Coaches Group. Just as this group is itself still evolving and re-evaluating itself amidst the ever changing rugby environment, I feel that it is now probably the right time to review the Appointment's Board protocols. I have raised the issue at both Management Committee and the Appointment's Board level. The members of both committees have generally agreed with my suggestion. This review process will be one of many important issues for the 2004 Management Committee to address.

I would like to use this forum to thank Cole, Geoff, Tom, Brian, Terry and Michael, on behalf of you, the members, for their stirling contributions to our association. They have the most important, yet often the most thankless task to perform within our association. I would also like to thank them personally for their support this season.

Finally, on behalf of the Appointment's Board, I would like to thank you, our referees and coaches for your tireless efforts on and off the park this year. I trust that you have all had an enjoyable rugby season. Rest up, enjoy the off-season (and the World Cup of course) and we look forward to seeing you all again in 2004.

It is with a great deal of thanks to the referee coaches, that I highlight for members, the contribution they have made to referee development in Brisbane over the past season. The coaches have continued to update their skills through a series of six development meetings over the season, attended QRU sanctioned carnivals, represented our Association on interchanges and been ambassadors along with our referees to ARU championships. Additionally, many of the referee coaches undertake to actively referee and / or serve the Association and the wider Rugby community through participation in other areas. These include the various areas of appointments (QRU & QRRA), judiciaries or the QRRA Management Committee and for some the wider context of ARU appointments. They give their time freely to benefit refereeing. A fact sometimes missed in the busyness of our season.

Despite their many commitments across the Association and the wider Rugby community the referee coaches have managed to write 325 reports on 135 of our members. This is the highest number of written reports for a season in this Association. This is an excellent achievement when you consider there were around 170 referee members in 2003. Around 80 % of regular, active, referee members have had at least one written report on them during 2003. When you compare this to 2002 (see below) this achievement is even more significant.

As perceived "world leaders" in referee coaching we have made significant progress in providing high standards in referee performance for Brisbane competitions. This can be directly attributed to the time and commitment that each coach has been able to give to their evolving role. This has been carried out whilst juggling demands on their time from Rugby and other personal commitments that impact on a volunteer role.

Despite the clever work of our appointment officers and the significant commitment of a number of referees, one issue that surfaced during the season was the shortage of referees that forced the return of some referee coaches to refereeing on those weekends when demand for referees was at its peak. If the maximum number of referees to be sighted and reported on over the season is be achieved we will need to look closely at a number of strategies. These strategies should consider reducing the number of matches appointed to in these peak times and/or increasing the number of referee coaches and/or increasing the number of referees through recruitment. More referees could have been sighted and reported on had we not been placed in the position of having to appoint a number of referee coaches to referee fixtures. However I am sure the referee coaches in their return to the field enjoyed the experience.

Another issue that re-surfaced this season occurred during the time when schools were calling on our services. One of our members was hassled by a school official after he has refereed a match. Several similar incidents during the school season filtered back to referee coaches. Referees reported they were put under undue pressure before, during and/or after matches and even harassed by over-zealous and passionate school officials. These officials were only intent on pointing out the shortcomings of the referee rather than a balanced discussion that involved their team's performance. I know the Management Committee has taken up their causes with higher authorities. From a referee coaching point of view, the sooner pressure can be brought to bare on the behaviours of these "officials" than the better off members will be and the greater chance they will develop as referees not to mention the possibility of attracting more members.

Association records from the middle of the year, indicate we have 15-Level I, 12-Level II, and by the end of 2003 we will have 6-Level III Referee Coaches in Brisbane with one more, Peter Gofton, to undertake the Level III course in 2004. There are also at least seven other members who are currently completing the requirements for accreditation at Level I & II. Such is the growing strength of referee coaching in Brisbane, a fact that referees should feel confident about for their development in the future.

Written Evaluations on Premier Grade Rugby received by QRU from QRRA Coaches

In addition to the above coaching reports, the QRU appoint referee coaches to each Premier Rugby match in the second half of the season. These coaches are expected, on the basis of match statistics and run sheet with video, to evaluate the referee performance and complete a match report used for appointment purposes. Whilst these are not coaching reports time is spent ensuring the accuracy and evaluating the referee performance using objective measures.

Interchange Report 2003

Interchanges for 2003 started a lot sooner than normal, when the Hong Kong Rugby Referees Association invited a representative from our Association to visit during the Hong Kong 7's and to referee in the Hong Kong 10's. Unfortunately, the time frame involved and the availability of an eligible referee meant that we had to decline the invitation for this year. It was to have been a marvellous opportunity for our Association, and is a strong indication of the respect overseas Referee Association's hold for our own organisation. One can only hope that the offer may be extended again next season, and that we may be better prepared to accept the invitation.

We were also approached by Auckland to commence a new interchange of a Referee and Referee Coach from each Association. It should have been obvious from the start that our Associations are perhaps at different levels of development, when the interchange co-ordinator does not believe in emails. Relying on the fax machine meant that communication lines were crossed, and a Referee and Coach from Auckland were waiting to be picked up from the International Airport in Brisbane 3 weeks before they were expected.

Needless to say, standing at the Deli counter at Woolworths with a screaming 2 year old was not the time I would choose to receive this information.

A number of rapid fire calls between Cole Barrett, my Practice and myself, during which time the battery on my phone ran out, resulted in me collecting the 2 gentlemen from Mallon Street and taking them back to my house. Imagine Julie's surprise when she returned home to find that instead of the weekly grocery shopping, I had brought 2 Kiwi's back with me. Again, letting the fingers doing the walking, Pat and Vee Rae saved me by hosting the Referee for the whole 10 days at EXTREMELY short notice. Paul "Taffy" Evans and his family stepped up as well, and hosted the Referee Coach from the following Monday after having spent the weekend at my house. To both Paul and Pat, but more importantly their long suffering wives, I say a very big thank you.

The remainder of the in-coming interchanges all flowed exceedingly well (comparatively), with good feed-back from the guys.

The out-going exchanges provided their own world of hurt, mainly regarding the Christchurch fellows --- but I will leave the reporting of that to them.

Auckland (13 June to 22 June)

Rodd Brockett and I left on an overcast day for Auckland as the first referee and referee coach exchange to Auckland from our Association. We were met at the airport and transported to our billets. Surprisingly the weather was warm and fine and that Saturday I went to the Suburb's Club to look at two referees and to meet some of the local coaches and assessors. Rodd was off to referee a Senior II game. The "coach" I met that day was heavily into assessment mode and he wasted little time in letting the referee know his shortcomings. His zeal was not just confined to after the game but he took full advantage of the half-time break to "coach" the referee. The second referee that day was billeting Rodd and his game, a Senior I fixture, was equivalent to our 1st grade and I thought he acquitted himself well and would not be out of place in our top 15.

The following day both Rodd and I went to a local club to see a Colt's trial match between Auckland possibles and probables. The game was entertaining but played in appalling conditions by our local standards. Heavy rain and a mud up to your ankles was the order of the day. After the game we had an interesting conversation with the referee who filled us in on the local refereeing scene. That Monday night we attended the Auckland Rugby Referees Association weekly meeting at Eden Park and after receiving a warm welcome we exchanged gifts and put two large bottles of Bundy on the bar. It disappeared rapidly. Note: Auckland referees appreciate a good rum. That evening was a combined meeting with the Auckland Rugby League Referees and a fun trivia night was had by all. Those fortunate referees who had been coached? the previous Saturday were required to front up and meet individually with the coach in the boardroom which I gather is no fun.

No games had been scheduled for mid-week so Rodd and I indulged in some sightseeing and we had an interesting day with John Gilles the referee education officer with Auckland Rugby Union. With few exceptions the Auckland refereeing culture is driven by what your ranking is. A typical greeting may be "I'm Bill Smith and I'm number 5." I was even asked what my number was and I'm a coach! By Tuesday afternoon it was no exaggeration to say that our collective experiences presented both of us with a sizeable culture shock. Our own "give it to them straight" coaches were tame by Auckland standards. We retreated to warmer climes to reflect. By Friday afternoon after having bathed in the warm sulphurous and curative waters of Rotorua, to heal our figurative wounds, we headed back to Auckland for Saturday's games.

Rodd was off to referee a Senior II game and I went to University Club, whose main field was of the standard of Ballymore #1, to see a young referee control his first Senior game (about our Div 2 2nd grade). For a first game he went pretty well and looked a good prospect. I then went to Marist's home ground for a Senior I game where the referee was being assessed for

promotion to the top panel. The ground at this venue was sub-standard by any measure. Even though there had been steady rain for most of the week the Marist's boys had watered the field turning it into a bog. This is a pre-match tactic often used by Marist it seems. Fair dinkum a 4WD would have bogged on that field. Surprisingly there was only one scrum collapse and players kept their feet despite the slippery conditions. I guess the 21mm metal boot tags instead of moulded rubber soles was the answer. My experiences of the previous Saturday were again revisited with the coaches dwelling on the negatives, offering few if any solutions and doing a great job of alienating themselves from the referees.

However during my stay I did discover some encouraging positives. Bill Sinclair, John Webber and John Gillies are some people wanting to change things and do believe in a coaching model similar to ours and are all working towards a positive change. John Gilles informed us that in all NZ there were only a couple of Level II referee coaches and that a level III programme may get underway in 2006 all being well. The Auckland Association is roughly the size of ours but has only one referee on the NPC panel of 21 which is an interesting contrast with Christchurch. Our Association provides a framework where we can get two referees to the World Cup so I guess we must be doing something right. At their current state of development Auckland has little to offer our Association in terms of referee or referee coach development other than to reinforce what Ian Scotney has been telling us that here in Brisbane we really are at the forefront of referee development.

On behalf of Rodd I would like to express my thanks to the Management Committee for extending to us the opportunity to travel to Auckland on this inaugural exchange.

Wellington (13 June to 22 June)

Paul Harding and I arrived in Wellington Friday evening and were taken to the Sportsman Bar for an introductory look at the city. That night Hardo stayed with Dan Dempsey at Upper Hut. Dan gave him a run down of the Wellington Referees web site. Each week appointments are posted on their web site and each referee is responsible for checking the web site to find out their appointment. Also located on a separate part of the web site is a coaches' section. Within this section is a copy of each coach's report on each referee. These reports can be accessed by referee coaches at any time. I was with Sean Newland, whose house had a breathtaking view of Wellington, topped off by being able to see eight rugby fields during the day.

Saturday PBH spent the day coaching. A coaching report was prepared for a Japanese referee who was in Wellington on interchange. The language barrier apparently made coaching a little difficult. I refereed Johnsonville against Wellington which is an 80/80 match. The players are under 80kilos and the match is played for 80 minutes. The 80/80 division is always fast paced and whilst I enjoyed being the heaviest on the field it was a hard test running around with them for a full 80 minutes. I received a coaching report from Harry Quinn, one of the senior coaches in Wellington, it was very comprehensive and beneficial. I then ran touch for one of the visiting Japanese referees in a Premier Division 2 match, Johnsonville versus Hutt Old Boys Marist. Afterwards we were all welcomed back to the clubhouse by the players.

Saturday night we were taken to the All Blacks v. England match at the "Cake Tin". It was a great night out and a good game of football. Whilst in Rome we had to do what the Romans do and support the All Blacks so it was a disappointing result. We made sure to let everyone know we were Queenslanders and Stuart Dickinson is from New South Wales.

On Sunday I was hosted by Dean Adams. We awoke to what I understood to be a typical Wellington day. Raining and windy. I was taken on a tour of Wellington and then spent the afternoon at the Museum. Monday and Tuesday were also days of leisure. There was little rugby. Kevin did a school girls game on Monday afternoon. The match was Upper Hutt College versus Wellington Girls College. This was my first time refereeing a girls match which was a great experience and a very close game of rugby.

Judiciary Report 2003

This year was no exception to the past few years in that it has been a busy time for the Committee, as we were occupied on every Monday evening throughout the season. In all, at time of writing, 101 players were sent from the field. I have attached a brief summary of statistics below to give some idea of offences and penalties.

The standard of send-off reports was again, in the main, quite good. Overall, I feel we are getting better at this and I suspect it probably flows from the improved "professionalism" of the Association generally.

Through the Management Committee, I was able to pass on pertinent information on some referees to the Referee Coaches. This occurred rarely, but I believe is an important activity in being able to provide feedback from another area that should ultimately assist in the development of referees concerned. It was very pleasing that the Referee Coaches accepted the comments in the spirit in which it was intended.

Next season, with the yet-to-be-obtained approval of the QRU, the Judiciary Committee is seeking to standardise the processing of the "one punch send-off" scenario. The proposal will be to allow such players to plead guilty, take the one-week penalty and not be required to appear. I emphasise that this is merely a proposal "in the making" at present. In due course, this obviously needs to be discussed, but I would appreciate, through the Management Committee, any comments members may have.

Finally, thank you to those who assist this aspect of the game. Particularly, thanks to President Peter and his Management Committee for their support and the QRU, especially our own Michael Backstrom for his hard work in making Monday nights work.

Lets keep up the great work next year.

Junior Judiciary Report 2003

It is a pleasure to report that, from the perspective of Junior Rugby players, the 2003 season saw a significant decrease in the number of players who were required to attend the Judiciary. Despite the rapidly increasing numbers of Junior Rugby players involved in competitions organised by the Brisbane Junior Rugby Union, it is apparent from my records that:-

- (a) the number of players sent from the field, particularly in what had previously been a problem area with relation to the under 17 pre and post season competitions, was significantly reduced; and
- (b) the severity of the send-off offences was also diminished (the majority appearing to result from striking offences after flair ups and from over vigorous rucking, rather than from intentional use of elbows, knees and other assorted body parts).

The statistics provided by the Queensland Junior Rugby Union confirm that cases relating to 30 players were considered by the Judiciary during the 2003 season. All players were found guilty and suspensions totalling 44 weeks were imposed as penalties:-

As a general comment, the majority of send-off reports prepared by members of the Association were adequate for their purpose, and on the whole these reports were better than in previous seasons. Having said that, there remains significant room for improvement, both with regards to remaining objective and including all relevant facts which the Judiciary members require to have before them to impose penalties.

Although the players were comparatively well behaved, there was a significant increase in citing of parents, coaches and managers involved in off field incidents (including several quite violent ones). In a worrying trend, quite a number of these incidents occurred during or after the completion of "Saturday morning games" for our younger players. All referees should be careful to comply with their game control requirements at all times, but not under any circumstances to become involved in verbal or physical disputes between opposing groups of parents or team officials.

Martyn Chalmers took on a large amount of the Judiciary appearances both in his own right and as a co-representative of our Association, with a view to his obtaining suitable experience to take on the role next season. Again, we should acknowledge the assistance of Tim Matthews who was required to sit in on a number of the disciplinary hearings which took place during this season.
