## **President's Report**

Events in late 2006 meant that the succession plan for 2007 detailed in last year's President's report did not proceed as planned. Whilst this resulted in the new Management Committee not carrying forward as much experience into the 2007 season as previous committees, the new committee was very determined that it would take a balanced leadership approach in managing the affairs of the Association on behalf of all members and the relationship with all our stakeholders. Management Committee members took on roles representing specific sections of our membership to ensure that their views were considered in making its decisions (eg Rodd Brockett represented senior and elite referees, John Christophersen new, junior and developing referees, Steve Williamson experienced referees and Barry Leask representing Life Members and Referee Coaches etc).

The Association was deeply shocked in February by the sudden passing of Stuart Tasker, our Secretary and dedicated colleague. Suffice to say, that the level of respect that Stuart held in the wider rugby community as well as in our Association was shown by the turn up of our members at his funeral. He was much loved and is sadly missed. The Management Committees recognised the long standing contribution that Stu made to our Association and has honoured this by the naming of our annual dinner "The Stuart Tasker Memorial Annual Awards Dinner" as a lasting perpetual tribute.

The greatest challenge that any leadership team faces is to plan the future of the organisation whilst continuing to manage the affairs of the day. The Association is like any workplace in that we have both the "up and comers" and experienced operators. There are those who believe that we should focus our resources on the future identified referees, whilst others want the focus to be on the experienced. The reality is that unless a balanced approach is applied, we would be doing a disservice to the Association members. Any respectable development process for young referees requires that they are provided with the coping skills for not always getting the games they think they deserve – this helps prepare them for the future. Equally certain types of games require an experienced hand – the use of our resources is not an exact science – retaining the balance is what we have aimed for.

In terms of looking to the future, we are acutely aware of the need to attract and retain sufficient members to meet future requirements. Rugby players have two entry level pathways — via the club and the school systems. Members will be aware that an entry level program has previously been delivered by QRRA to BJRU referees in the under 9/10 age group. Its success can be seen by the transition of 26 referees into QRRA ranks in the past year from this program. 2008 will see our entry pathway expanded to match the player system with the launch of a school based entry program, similar to the club program. I am grateful to Richard Bendeich and Kevin Crowe for their role on a QRU sub-committee which resulted in the concept coming to the Association for implementation. One further program we are investigating is that through players nearing retirement, who wish to stay involved with the game can join the referee ranks. Scott Young has agreed to assist with the promotion and development of these programs.

This also applies to the finances of the Association. The diligent work of previous committees has provided a stable base for this committee to commence, which was particularly vital with the QRU cutting our administrative grant by a third. Fortunately, we have been able to replace this funding from another stakeholder, the BJRU and have added additional sponsors to ensure the ongoing future financial viability of the Association. We are very fortunate to have a Principal Sponsor, who is as supportive as the Queensland Rugby Union Club – we are in the fifth year of this sponsorship and they have indicated that they want to see this fruitful relationship continue. Thank you QRU Club. Another long term sponsor Cooper's Plains Dental Surgery has further increased its sponsorship by another third - your long standing support over the past 8 years is much appreciated. After the departure of Centenary Mazda after one season, we signed up Genworth Financial to a 3 year shorts sponsorship – we look forward to a long and fruitful relationship. As this report goes to press, we are negotiating with a new sponsor for our touch judge flags and these will be in place for the start of next season. Lastly, I would also like to pay tribute to our least known sponsors -Rodd Brockett, Rob McAfee and Shane Sullivan for providing our training kit, caps and referee coach jackets.

At the same time, member needs have not been neglected with newly designed playing shorts, upgrade jerseys, new co-ordinated training kit, polo shirt, caps, redesigned tie and referee coach jackets. One lesson learnt from this year's experience has been to order early (ie at the end of the previous season) because clothing suppliers have a track record of over promising and under delivering. The certainty that we now have with our sponsorships means that we can now confidently order playing strip in advance. We are looking to expand the kit available next year to encompass new gear for the referee coaching group.

The Committee also recognised that we do not exist in a vacuum and that if we are to continue to be regarded as a respected peak body for refereeing, the committee needed to take positive steps that illustrate QRRA (Brisbane) Inc does not inherit this role by default but is indeed worthy of holding such a leadership role.

I am pleased to be able to report that QRRA (Brisbane) has stepped up to the plate in this regard and is now working in conjunction with a number of our rugby partners to advance the development of referees, not only in our Association, but within the wider rugby community.

#### State Referee Committee

In the past, there has been some underlying feelings that this committee could be operating counter-productively to the interests of our Association by the diversion of resources, particularly for our elite and developing referees.

Perhaps firstly, the role of the SRC needs to be made known to all members. Its function is to oversee the development of referees throughout the State as well as appointing to Premier and Representative fixtures. As Brisbane has the largest number of members, it should be expected that we will be over represented in the squads compared to other Associations. It must be remembered that the SRC cannot exist without the member

Associations. The bottom line is that SRC committee members, bar one are all members of QRRA as are all of the referees in the senior squads.

Secondly we need to think of our elite and development squad referees in the same manner as representative footballers are within the club structure – would the Broncos players get upset because extra resources are put into Darren Lockyer as a Test Player or other State Of Origin players – no - because it helps make them better players and assists in the development of lower grade players. We need to think of our elite referees in the same manner.

Thirdly, the frameworks for development and training methods developed for squads have been deliberately incorporated into QRRA training and development nights with testing held together on the same nights. All training sessions are conducted by QRRA.

Lastly, development opportunities are now being shared so that members have access to these development opportunities including refereeing international teams. These carnivals are no longer the exclusive province of development squads (eg The Gold Coast Schools Carnival).

#### QRU and its affiliate bodies

I would like to recognise the contribution of QRU staff members, Ken Freer, Simon Taylor (and Luke Wyatt before), Michael Backstrom, David Hanham, Mark Melrose, Scott Wallis and Peter Curtis for their assistance during the year. I would also like to acknowledge the strong support provided to referees by the QRU Judiciaries (senior and junior), and in particular, Chairman, Harold Shand, who also provided advice on a number of occasions.

In previous years, referees have not always been represented in the same manner as clubs and players. Whilst we have been represented on the BRC and BJRU previously, this year has seen direct representation on the President's committee, Sub Districts and Premier Committees.

Our contribution to the State Junior Championships over the past two years has seen Barry Leask invited to sit on the Queensland Junior Rugby Union Committee.

#### Schools

We have been fortunate that a number of our members have assisted many schools in their refereeing programs for the lower grade games. In 2007, we ran an accreditation program to assist the schools in providing additional resources. This program will be extended in the next year to provide an additional entry pathway for refereeing. In 2007, as an interim solution, we delivered 2 accreditation courses specifically tailored for school based referees.

#### Other Referee Associations

Whilst it is true that each referee association within our state operate independently, our near neighbours (Gold Coast, Darling Downs, Sunshine Coast, Rockhampton, and Far North Coast of NSW) have looked to QRRA (Brisbane) for leadership and guidance. All of these associations provided

strong representation at our camp in January and we have also provided assistance to each to meet their occasional shortfalls in refereeing numbers.

The internal exchange program successfully introduced last year was further expanded to include Bundaberg and a junior exchange in May to provide valuable experience in preparation for the State Junior Championships. The feedback from our country cousins has been overwhelmingly positive, with our members representing our Association proudly.

## Visiting Referees

Queensland refereeing enjoys a strong reputation around the world. In 2007, we have sought to build on this by providing fellowship to the visiting referees for Test and Super 14 Matches in Brisbane.

I am pleased to advise that we have been able to negotiate a further increase in remuneration levels from the Brisbane Rugby Committee (with flow on to other competitions) to enable additional remuneration to be paid to our members. Further increases are also on the table for the 2008 season in both junior and senior rugby. In the ideal world, it would be desirable for the levels of remuneration to be increased to reflect the importance of the role, but we must remain cognisant that the vast majority of rugby played at the community level is unpaid and funding for referees comes from the players themselves, who are more than willing to pay this levy, but this is not a bottomless pool and we cannot afford to price ourselves out of the market - players could just walk away from the game meaning we have reduced games to do. Ideally sponsorship of the various competitions could provide a partial answer, but given that many games which are played in front of friends and family only this will never be the complete solution. The challenge going forward is to ensure that our remuneration levels can be increased to maintain high levels of excellence and expertise (including attracting new referees), but importantly that there is a guaranteed source of revenue to support this - a major challenge in virtually amateur based competitions refereed by an Association sourced almost entirely by volunteers.

The achievements of season 2007 are undoubtedly highlighted by Paul Marks's test debut and selection as a touch judge at the World Cup, where he was joined by Ian Scotney, continuing the rich tradition of Queensland being represented at every World Cup. Geoff Acton was again appointed to Touch Judge duties in Super 14, Schoolboy Test Match, ARC and representative fixtures as well as being appointed to the Premier Grand Final. Our two leading referees have not forgotten their roots and have shown great leadership within the Association for which I am extremely grateful.

#### Other highlights include:

- ARC and representative fixtures for Simon Moore.
- Representative appointments for Steve Leszczynski, Craig Hills, Paul Twomey, Alastair Mould, Stephen Hill, Paul Haydock, Michelle Colgrave, Luke Spence, Shane May, Paul Heagney, Jason Lees, Andrew Coorey and Cameron Stanfield.
- Championships for Paul Twomey, Craig Hills (Schools Div 1), Paul Haydock (Schools Div 2 – including the final) and Michelle Colgrave (Under 16).
- Premier Grade debuts for Paul Twomey and Stephen Hill

- Representative coaching, reviewing and assessment appointments for lan Scotney, Andrew Cole, Scott Young, Geoff Pegg, Terry O'Connor, Peter Gofton, Peter Smith, Paul Heath, Paul Evans and Neill McCann.
- Tom Ryan as Referee Liaison Officer for Test Matches, Super 14 and ARC matches.
- All semi and grand finals referees on your appointment and for providing such a high standard throughout the finals series, making the job of selection difficult for our referee coaches.

There are two disappointments from the 2007 season. Referee Coaching, whilst quite strong for those with appointed coaches, suffered from a lack of focus at the community level, partially due to the fact that the next generation of referee coaches are still active referees and the fact that senior referee coaches have been required to cater for the expanding representative calendar. To address this in 2008, it is intended that a specific Community Referee Coaching Director be appointed and we will be working with the SRC to make 2008 "The Year of the Coach". The second disappointment was a long winded disciplinary matter, which distracted the Management Committee from dealing with our core business. Thanks go to John Forbes, Ross Landsberg and Mark Logan for their roles as part of the Disciplinary Committee in resolving this matter.

This year we bid farewell to two of our loyal servants from the past few years. Clarie Chappell has retired as our trainer due to relocation and injury and this role will now be filled by Shane May, who many of you will be already be familiar with. John English, our Administrator is also moving on – many thanks on a job well done and for the dedicated service both of you have provided to QRRA members over the past few years.

Our Association cannot function without the efforts of many volunteers and their families. I would like to thank the following for their dedicated efforts in 2007:

- Geoff Gardiner, Marty Chalmers, Mark Hogan, Peter Backstrom and Chris Newton for representing the Association at judicial hearings and appeals.
- The Appointments Board Barry Leask, Brian O'Donnell, Peter Backstrom and De Wet Van Der Nest thank you for dedicated service on this thankless task the most visible of the Association. This group has forged close ties with the SRC particularly, Geoff Pegg, to ensure that appointments were completed in a timely and transparent manner.
- Mark Logan and the Coaching team including Michael Petrie thank you for the assistance provided to our members.
- Michael Wallace, our gear steward for the sterling work in managing the referee's room and gear.
- Paul Heath for his work on re-developing our website to make it more user friendly and useful to members and stakeholders. Paul's expertise will be welcome as he joins us as the Executive Officer for the Association.

I have been very privileged to work with a dedicated and loyal Management Committee this year, who all deserve your thanks and praise. John Christophersen took responsibility for new members and editing "The Short Blow", Rodd Brockett for organising our meeting nights including catering, Steve

Williamson for further building great international and inter-association relationships through his stewardship of the interchange program after taking over from Darren Rees, Paul Daly for taking on the arrangements for the Stuart Tasker Memorial Annual Dinner as well as the lead on the new school based program and Rob McAfee as our expert on financial matters. A special vote of thanks to Mark Hogan, who stepped up to take on the role of Secretary after Stuart's passing – your wise counsel and dedication is much appreciated. The role that Barry Leask has played this year cannot be underestimated. As a Life Member, he would be more than entitled to "put his cue in the rack" but rather he put the needs of the Association ahead of his own and has been a true and loyal deputy, and I am indebted to him for his unwavering support and genuine mateship throughout the year.

Finally, thank you to all our members for your support, camaraderie and friendship that you have provided this year. It has been a real privilege to lead this Association – it is my sincerest hope that the Management Committee has improved the culture of the Association so that we leave it in a far better position than at the start of the year.

## 1. Summary of Significant Accounting Policies

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Associations Incorporation Act (Qld) 1981. The management committee has determined that the Association is a non-reporting entity and therefore there is no requirement to apply accounting standards and other mandatory professional reporting requirements in the preparation and presentation of these statements.

The statements have been prepared in accordance with the requirements of the Associations Incorporation Act (Qld) 1981. The statements are prepared on a cash basis, whereby items are bought to account as money is paid or received, from the records of the association. These are based on historical costs and do not take into account changing money values or, except where as specifically stated, current valuation of non-current assets.

The accounting policies have been consistently applied, unless otherwise stated. The following is a summary of significant accounting policies adopted by the Queensland Rugby Referees Association (Brisbane) Incorporated in the preparation of the financial statements.

#### (a) Taxation

As of 1 July 2000, the association was registered with the ATO for GST purposes. It is a non-profit organisation that has voluntarily nominated for GST.

No provision has been made for income tax as the association is exempt from income tax under the provisions of section 23(g) of the Income Tax Assessment Act.

The Association was and still is not required to have a Tax File Number.

The Association collects and pays GST quarterly. A Business Activity Statement (BAS) is submitted to the ATO on a quarterly basis as required by the taxation legislation.

#### (b) Stock on Hand

All bar stock and referee's apparel are expensed in the year of purchase.

#### (c) Equipment

All equipment purchases are expensed in the year of purchase.

For control purposes such items have been listed on the register of non-current assets/chattels.

### (d) Events subsequent to Balance Date

Significant items of income and expenditure subsequent to balance date but prior to AGM are noted in Note 15.

#### 2 Change in Accounting Policy

The Association has formally changed its accounting policy to cash accounting from accrual basis, which had only applied to GST in prior years. The comparatives and retained surplus have been restated in order to reflect the change and properly present the financial statements.

The Association's Committee of Management is responsible for the financial report and has determined that the accounting policies used and described in Note 1 to the financial statements which form part of the financial report are appropriate to meet the requirements of the Associations Incorporation Act 1981 (Queensland) and are appropriate to meet the needs of the members. We have conducted an independent audit of this financial report in order to express an opinion to the members of Queensland Rugby Referees Association (Brisbane) inc. on its preparation and presentation. No opinion is expressed as to whether the accounting policies are appropriate to the needs of the members.

The financial report has been prepared for the purpose of the requirements of the Associations Incorporation Act 1981 (Queensland). We disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

Our audit has been conducted in accordance with Australian Auditing Standards. Our procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial report and the evaluation of significant accounting estimates. These procedures have been undertaken to form an opinion as to whether, in all material respects, the financial report is presented fairly in accordance with the accounting policies described in Note 1 so as to present a view which is consistent with our understanding of the Association's financial position, and performance as represented by the results of its operations and its cash flows. These policies do not require the application of all Accounting Standards and other mandatory professional reporting requirements in Australia.

The audit opinion expressed in this report has been formed on the above basis.

#### **QUALIFICATION**

As is common for organisations of this type, it is not practicable for Queensland Rugby Referees Association (Brisbane) Inc. to maintain an effective system of internal control over income and expenditure until the initial entry into the accounting records. Accordingly, our audit in relation to receipts and payments, other than interest income, was limited to amounts recorded

## **Appointments Board Report**

In 2007 the Association appointed and provided referees to 3,296 games, including 1,154 in the Brisbane Rugby Committee Competition, 1,575 in the Brisbane Junior Rugby Union Competition and 567 in the GPS, AIC and TAS Competitions with 185 members of the Association appointed to games this year. Our members were also appointed to representative games by the IRB, SANZAR, ARU and the SRC including Premier Grade games.

The Appointments Board, which comprised Brian O'Donnell, Peter Backstrom, De Wet van der Nest and myself, thanks all members who accepted appointments this season, particularly those members who assisted at short notice to fill vacancies due to withdrawals by other member after the release of appointments. The support provided by our members' families is also very appreciated.

Further, I would like to express my personal appreciation and gratitude to Brian, Peter and John English, the Association's administration officer, for their efforts in fulfilling the week to week appointment commitment this season. On a few occasions I took on the duty of nominating replacements for unavailable appointees and can attest to the onerous and often thankless tasks these gentlemen carried out on a daily basis. On behalf of the Association I thank you.

The assistance of Geoff Pegg (State Referee Committee), Michael Backstrom (QRU) and Kim Schuck and Karen Greedy (both BJRU) as well as the rugby coordinators from the GPS, AIC and TAS competitions was also greatly appreciated. Without their co-operation and professional expertise the Board would not have been able to perform its duties to the same extent.

This season the Board took a narrower view compared with the last few seasons, particularly in relation to senior grades, by attempting to appoint to a stricter performance formula. This permitted the Association to provide referees to matches closer to their comfort zone and the abilities of teams involved. As a result there were very few formal complaints received this year regarding referee performances and I believe that members attained satisfaction from carrying out their appointments.

The Appointments Board's gratitude must be expressed for the efforts of the Boards of the last few years for their efforts in providing opportunities to members on a wider scale. These tested members' abilities and gave this year's Board a wonderful base of performance and experience with which to perform its task.

There are two behaviours that disturb me, both as chairman of this Board and as a member of the Management Committee of the Association.

The first is abuse of our members at matches. Such behaviour needs to be addressed by the referee involved, the Association and the body organising the competition. However the most important part of the equation is a timely, detailed report from the referee. If the Association is not made aware of such incidents it cannot support the member involved and those who follow. I must compliment the Brisbane Junior Rugby Union for their speedy attention to such matters. Please support each other and inform the committee so that it does not ruin your leisure activity – refereeing.

The second is the matter of 'No Shows' at matches. This Association makes a commitment to the organisers of the various competitions to provide competent

referees to matches. The appointments to these matches are made and promulgated in as timely a manner as the Board is able. It is disappointing to then have members either pull out of appointments within 24 hours of the match or not appear for matches when the appointments have been both forwarded personally by email and posted on the Association's website several days before the match.

The timely provision of availability (or more specifically, unavailability) by members is extremely important to the appointments process. With the enhancements to the Association's database facilities in 2008, such information will be able to be recorded and utilised more accurately. This will reduce the time currently wasted by the Association's appointments officers and administration in redrafting weekly appointments, however this will place a greater onus on members to maintain their accurate availability details.

This season I implemented the practice of attempting to contact any member who did not show for an appointment as soon as that information was provided to me so that I might gain an explanation for the occurrence. On most occasions this season the explanation has been acceptable. Although this is not a practice that I personally enjoy, I will continue to attend to this task while I remain Chairman of the Board.

The other concern for this Board is the Association's ageing population. This is an issue that will need to continue to be addressed in the future, however I will leave this to the incoming committee, State Referees Committee and the Queensland Rugby Union.

Finally, I would like to congratulate all those members who worked so hard during the season. Of particular note are the Association's on-field leadership team – Paul Marks (Rugby World Cup), Geoff Acton (Super 14) and Steve Leszczynski (Captain SRC) – who set a wonderful example for all members – as well as all those members who supported the Association at whatever level and progressed in their refereeing skills.

I hope you all have a relaxing break over the short off season and return revitalised in 2008.

## **Referee Coaching Report**

As is always the case at season's end, it is difficult to express the degree of gratitude and heart felt thanks that should be extended to the referee coaches within our association .As most coaches are still active referees, the time they give to the continued development of the association as a whole as well as on a personal level, is nothing short of amazing.

The continued growth of the State Referee Committee (SRC) in the role of coordinating referee and referee coach development across Queensland has been a real positive for the association. Whilst this committee is primarily composed of members of our association, their independence I believe is an important plus. It has and continues to provide an environment for the further development of harmonious relations between the numerous referee bodies in our state. The expansion of the intra-state interchange programme this year highlights this point beautifully. It has allowed the programmes put in place by the SRC to achieve better outcomes.

In accepting the role of Referee Coaching Group Co-ordinator (RCGC), I advised not only our Management Committee but the referee coaching group that I was not really interested in the number of written reports compiled in 2007. Unfortunately, previous administration, including those chaired by myself have become too focused on numbers. The success or failure of a coaching programme should not be judged as some would have it, by a number! Just being present at rugby venues to provide support to our fellow members, be they referees or coaches is vitally important. Too often in the past, the feedback from many referees has been "I have not received a written coaching report this year!" Conversely, referee coaches have been at pains to explain the time necessary to compile worthwhile coaching reports. Certainly way more time than that required to just referee a game – a point quite often lost on some our members. Hence my reasoning behind not being concerned about number of reports written!

Personally, I attended quite a number of locations throughout the season, chatting to referees(and coaches), discussing issues they may have had, sometimes discussing questions of law or just how to handle certain situations based upon others experiences. All hopefully helping them become better referees for our association. I believe by doing this, that I am contributing in a positive way to referee development also. Others may beg to differ.

The referee coaching group met on four occasions in 2007. Terry O'Connor presented three excellent seminars based around his coaching work with Japan Rugby Union. The time that Terry put into preparing these seminars was nothing short of outstanding. Terry certainly is a gifted educator and we are lucky to have him as a member of our association. The only downside to these meetings was the limited number of coaches who found time to attend. As the services required of our members both on and off the rugby field increases every year, time is a precious commodity.

I would like to take this opportunity to thank my predecessor, Geoff Pegg. Geoff has again compiled the statistics for the association with respect to referee coaching. Geoff's knowledge and commitment to the development of both referees and referee coaches is second to none. He is an integral member of the SRC as well as our association.

Congratulations to Paul Evans on being awarded the Duffel-Jones Award in 2007. Paul has been very active this year, directly and indirectly contributing to and the promoting of referee development within our Association. Well done Paul.

In conclusion, I would like to thank all referee coaches for their support in 2007. Your efforts are very much appreciated, a point that the rank and file of our association too often take for granted. Thank you and enjoy the off –season.

## **Judicial Report**

The role of the Judiciary is an unenviable but necessary function required to support any well organised competition to ensure that the competition retains its integrity. Both the QRU and BJRU Judiciary recognise this importance and are dedicated committees determined to minimise the occurrence of foul play.

QRRA has been represented in an exemplary manner in 2007 by:

- Geoff Gardiner on the QRU Judiciary as primary appointee with Chris Newton as alternate. Mark Hogan and Chris are on the appeals board.
- Martyn Chalmers on the BJRU judiciary as its primary appointee with Chris Newton as the alternative. Peter Backstrom has also represented the BJRU on this body and Mark Hogan being on the Appeals Board. Thank you gentlemen for your selfless contribution.

Both judiciaries are very supportive of referees, firmly adopting the policy that the referee is the sole judge of fact and the onus of proof is on the player to prove otherwise. In practical terms, both judiciaries have proven through their rulings that they support these policies.

Many thanks to Michael Backstrom at the QRU and Karen Greedy and Kim Shuck at the BJRU for their administrative assistance and to the fellow judiciary members for their assistance.

This year also saw the introduction of the automatic week suspension for all send offs unless the player chose to contest the charge. The Chairman of each judiciary reviewed each send off report and if the offence warranted a greater suspension, the players were then requested to attend the next meeting for hearing and subsequent determination of an appropriate penalty to impose. The adoption of this policy, whilst being slightly more onerous on QRRA members provides a much more efficient method for dealing with cases.

The standard of send off reports were generally quite good and effective, but of course, there will always be room for improvement. The key word is conciseness – not too brief as to leave out key details but not too long winded to cloud the issue. Something for all of us to consider.

For the statistically minded, here are the details of send-offs for the season compared to last year. There are some very pleasing results

- An overall reduction in the number of send offs by 34% with seniors down by 25% and juniors by 49%. This is a firm indication that foul play will not be tolerated and the support that the judiciaries have provided to referees.
- A reduction of the proportion of Colts players sent off from 43% of senior send-offs to 35%.
- The offences based on QRU policy of automatic send-offs have reduced by 30% during the year.
- Code of Conduct offences have fallen significantly with a single offence in 2007
- These statistics do not include the send-offs at school levels but these are now being monitored at the competition level (ie GPS and AIC Sports

Associations, rather than at the individual school level). Feedback from these sources is that the number of send-offs has also reduced.
