### PRESIDENT'S REPORT

This report is my first as President and it comes after another rewarding and challenging year for the QRRA (Brisbane), its members, Committee, and myself.

2020 has been a year of many challenges and trials for the association and individuals. Fortunately, one thing has not changed, and that is the commitment to service as volunteers by QRRA members, whatever their age, experience, or level of expertise. A great majority of our members, referee because it is an enjoyable pastime which allows us to give back to the community and help instil life values. These values are stated by Rugby Australia as Teamwork, Respect, Enjoyment, Discipline and Sportsmanship. Without saying, the opportunity for intentional exercise is a valued benefit of refereeing.

Please let me take this opportunity to thank all members again formally for their commitment in providing the community with a generally enjoyable and well managed pastime.

#### **Sponsorship**

QRRA could not exist and achieve its goals as an independent volunteer body without financial support - It is worth remembering that the QRRA is a member of the QRU, not a subsidiary of the QRU.

This season we completed the final year of the sponsorship commitment by Shaw+Partners and I would again like to thank QRRA member Shayne Gilbert for the negotiation and continued support of the sponsorship, and our Treasurer Simon Moore for his efforts in providing extensive exposure to our major sponsor. Currently, discussions are being had with various businesses to secure sponsorship in 2021 and beyond. Thank you to Alan McLaughlan for his role in these discussions. It must be noted that potential sponsors are now very keen to be able to quantify potential return on investment as opposed to brand exposure. This is a result of the economic impacts of Covid.

Our associations with Allsports Physiotherapy and XRadiology have continued and are grateful for their practical support – in particular, the participation of the team from Allsports (Ms Sophie Dodd) to assist our fitness training and rehabilitation during the year.

I urge you to promote our sponsors, wherever possible, so their contribution receives the deserved recognition.

When the new sponsorship arrangements are in place, they will be communicated with the membership.

#### On the Field

Resulting from our work with the Rugby Australia referee team, and with our own education, coaching and fitness efforts, it is pleasing to see further success for QRRA referees across a range of levels. I am intentionally choosing not to single referees out for special mention this year as all have been called upon this year to do the extra-ordinary. Notable achievements of referees are listed within the annual report document.

Yes, we have had referees officiate test matches, Super rugby, Super rugby Au, Premier, Suburban, junior club, and schools. Let us not forget the university competitions, sevens and the many community competitions we are asked to officiate at. To this point I would like to thank those

members who over a number of weekends volunteered to referee 5 or 6 matches. When I talk of the extra-ordinary this is some of what I mean. I also wish to thank those members who continued to referee with overuse injuries.

#### BCE or CE?

Any time before mid-march can be referred to as BCE (Before Covid Era) and after that time CE (Covid Era).

In the BCE times Super Rugby had started and run numerous rounds with some of our members officiating in matches in various locations including Argentina. Another was in the South Pacific refereeing. As the shut down was happening these referees had to be rushed home before borders shut and then into quarantine. Locally, it meant competitions which were either in first rounds or trial matches were "wound down" and paused.

During the pause the Association in partnership with Rugby Australia were able to shift to more regular referee and referee coach education. These happened once a month each and delivered via Zoom. Thanks to Rohan Hoffmann and Cholm Johnson for facilitating this.

Time continued and rugby was able to re-commence within the CE frameworks. A simple outworking of this was the compression of the season including the playing of the three school seasons in Term Three. Apart from the previously mentioned need for referees to officiate more games than they would normally undertake it also required a reduction of referee coaching so as much of this human resource could be put to refereeing matches. These sessions were able to be continued when matches recommenced.

#### **Drivers of Success**

As an association we do strive to not only provide a service but the best service we can. Whether it be referees appointed to under 10's or through to Premier grade. Or, developing referees for higher appointments such as Super Rugby, International matches or 7s.

There have been two main pillars to achieving this in 2020. Firstly, has been the more regular education sessions for referees. These sessions have been intended to be not only relevant to the needs of referees but also timely as when the issues and concerns have been needed to be talked about. As these sessions were run on Zoom it was possible to use breakout rooms to enable the facilitators to ensure smaller group discussions were relevant to the needs of referees who officiate at different levels and have different sets of experiences.

The second pillar is fitness. The association has engaged Ms Sophie Dodd to co-ordinate the fitness sessions. The sessions in BCE were held at Ballymore on Wednesday evenings. When rugby was recommenced due to the unavailability of Ballymore the sessions were moved to Easts on Monday evenings. Pleasingly, numbers have increased since the return to rugby.

### **Some Costs of Covid**

The obvious cost of Covid for the association was the loss of part of the rugby season. Thankfully, this was only part of the season and we as part of the rugby community could still enjoy the game of rugby. There was a financial impact as we operate on a fee for service model if we have a reduced number of games this revenue stream is reduced. Tied to this the fact that is several our expenses are fixed and still must be paid whether games are played or not.

In 2019, the association commenced a junior development program which had a focus on referees who were still at school or young and in their early years of refereeing. A key part of this program is a modified version of the Association Launch Day. This day was due to happen on March 15. If you recall this was a key date in the Covid shutdown beginning. Consequently, this event had to be cancelled; other parts of the program such as the tick and flick coaching reports were still able to be used.

Refereeing for a proportion of our membership is more than refereeing the games they are appointed to but their social network. This was a concern if rugby was not operating for an extended time coupled with socially encouraged isolation that some members may become affected by not being part of their regular social groups. Thank you to each of you who took the time to contact your fellow referees and check in on them when needed.

Referee Coaching had to be wound back a little in 2020. As previously mentioned, this was to enable coaches to be appointed to referee games so our refereeing stocks could be bolstered to meet the demands of covering all the games in the compressed season. In 2021 we will be working on the goal of every referee having the opportunity to be coached at least once in the season.

#### **Challenges**

In last year's report the following was written:

"While QRRA has increased its membership in the Junior and Competitive age groups, our ongoing urgent challenge, due to the Association's ageing population, is the recruitment and retention of young females as well as males in the 30plus age group." This remains a challenge for the association and one which is to be a focus in 2021.

As in previous years referee abuse has been a concern. The focus of the association is to provide support where we can for our referees if they have been abused. While our focus is supporting our referee we also work in with competition managers and clubs to ensure that the instigators of abuse are appropriately sanctioned but also as part of the education process aimed at developing respect for all members of the rugby community.

Again, I will lift the words from the 2019 report which said:

"Therefore, if you experience or witness an issue, please raise it with the Association in a timely manner, so that a detailed and accurate Abuse Complaint can be lodged through with Rugby Australia if appropriate, so that it can be addressed at the source. Also support your fellow members in such instances."

However, respect is a 2 way street, and all members should be mindful of conducting themselves in an appropriate manner, even under extreme provocation, when they may be identified as a member of QRRA. This also relates to any postings on social media which could fall within the parameters of Rugby Australia's Code of Conduct."

### **Thanks**

To the 2020 Committee, I express my thanks for your teamwork and friendship, and for your input, guidance, and support in leading the Association. Barry Leask (Vice President), Gert Erasmus (Secretary), Simon Moore (Treasurer) and Committee members Alan McLoughlin, Michael Kent, Michael Orgill and Cholm Johnson.

Further, I thank Administration Officer Nicholas Joseph, Senior Appointments Officer Geoffrey Pegg and Junior Appointments Officer Laurie Monaghan for the endless hours that they put in maintaining the core business of QRRA – communication and referee appointments. Along with these gentlemen are our Referee Coaching Co-ordinators, Neill McCann (Senior) and Cole Barratt (Junior).

Our relationship and collaboration with the major organisations that QRRA provides its services to – QRU, BJRU, QSRU, Clubs and the 3 schools associations, including Jeff Miller and his Board, David Hanham, Gaven Head, John Miller, Kim Schuck and Craig Eason, continues in a positive and progressive manner.

### **APPOINTMENTS OFFICER'S REPORTS**

### **Senior Appointments**

The 2020 season provided many challenges for us in dealing with Covid-19 and then a delayed start to the competition which required appointments for matches on Thursday, Friday and Saturday. The biggest challenge to undertake was that all competitions, Brisbane Grade, Colts and Women's, Suburban, GPS, AIC and TAS were all occurring at once and at times required appointments for up to 132 games over the three days during the competition. With Thursday and Friday being night matches, referees appointed to these matches were again utilised on the Saturday, if available. To cover all Saturday fixtures, a number of referees were appointed to early morning games, possibly below their normal level, and then appointed to Schoolboy matches in the afternoon. A further difficulty with appointments was when Brisbane Competition as well as GPS games where scheduled for the Gold Coast or in Toowoomba. This was a logistical nightmare as referees appointed to these games could not be utilised elsewhere.

To all those referees who doubled up over Thursday, Friday and Saturday and to those who willingly travelled to the Gold Coast or Toowoomba, some more than once, my thanks and gratitude to all of you. To all referees who kept their unavailability up to date or contacted me regarding their availability, thank you as this makes an Appointments Officer's job a lot easier and less time consuming.

Due to Covid-19, no Schoolboy Aged Championships or State Junior Championships were held during 2020. Not having these Championships did not allow us to continue our Referee Development Program for younger referees although some younger referees were appointed to Schoolboy matches so their performances could be reviewed.

With the disruption and delayed start to the season, this placed the requirement to fulfil all appointments a priority and as a result, Referee Coaching was affected greatly. This resulted in many of our Referee Coaches being utilised as Referees thus reducing our overall capacity. In consultation with Neill McCann, Senior Referee Coaching Co-ordinator, we were able assign those who do not referee anymore to review selective referees and these Referee Coaches made strong contributions this season.

To all Referee Coaches, I extend my thanks for the many appointments that you undertook during the year and for your feedback on the Referee which assisted in their ongoing appointments.

To everyone, thanks for your assistance in 2020 and may 2021 be an enjoyable and successful season for you.

### **Junior Appointments**

To say the 2020 season was unprecedented is a little understated. In my 6 years as AO, this season, albeit a truncated one, has been by far the most difficult to manage. However, the positive from all of this was the fact we had a junior competition in the midst of a pandemic. A fine testament to the BJRU who managed significant health and government protocols to enable teams to gather, train and ultimately play in organised competitions. The Association would like to thank their efforts in providing a viable competition during the season – well over 1100 games.

As the pandemic encroached on our day to day lives it is difficult to characterise the season in any meaningful form. It had a profound impact on availability of referees particularly on our school age referees who had to prioritise school study, playing commitments (school/junior teams) and refereeing in the midst of restrictions of one sort or another. As a result, we 'lost' a number of junior refs and we will need to follow up with them next year to entice them back to the Association.

The same impacts also extended to our older referees and was felt most when all the school competitions (GPS, AIC and TAS) converged at the one time. This placed enormous pressure on referee appointments for both Saturday and Sunday with a high number of double ups and even triple games on the one day. For a number of referees this crossed over to both Saturday and Sunday appointments. Thank you to all referees who responded to my various requests to back up and/or go to other locations to fulfil appointments. Clearly, without your commitment and support this season would have been disastrous.

Again, even a season beset by a pandemic, we had to deal with poor behaviour from officials and spectators across all age groups including school games. The poor behaviour also extended to the summer 7s competitions played around Brisbane and seemed to gain gravitas in the younger age groups U9 – U11 where coaches and parents became agitated and lost sight of what the 7s competition was about. It continues to be a blight on our game and as I have said in previous reports can affect the retention of referees in both the short and long term. This is a critical issue for the Association next season. I believe we need to be more proactive with our stakeholders and dare I say, more assertive with our response to misbehaving individuals and teams.

As we approach the new year it is hope that we will return to some form of normalcy for next season. To coin a phrase – 'onwards and upwards'.

### Referee Coaching

As we all know season 2020 provided more than the usual challenges and this was never more evident than in our referee coaching functions. As the season began, the full intent was to build on the platforms and target groups that had been successfully established in 2019.

The changes to the season structure with club, sub-districts, school and junior competitions all being run concurrently in compressed timeframes severally impacted on the Associations ability to appoint referees based on sheer numbers meaning that many referees were doubling as well as referee coaches being required for on-field duties thereby restricting the ability for these coaches to provide referee coaching to our other members. This was extremely frustrating for referees, coaches and administrators alike but the reality is that the primary goal of the Association is to provide referee services to our stakeholders and this just had to take priority.

In terms of reports for the year (see below), there is no question that this is far lower than prior years but as indicated above this is primarily attributable to the nature of the season.

This effectively puts us in effectively the same position with the same challenges as we were at the end of last season. The perennial challenge for referee coaching still remains that no matter how much is dedicated to the function, there is always the feeling that more could be done. In order to meet this challenge, essentially to get the "best bang for buck", the Association will continue with the segmented approach targeting specific groups with tailored programs for each.

- Developing Junior Referees
- Hobby and Social Referees
- Senior Competitive Referees
- Squad Referees

The challenge for future seasons remains how can we get more from the limited coaching resources we have with a focus on the recruitment of more coaches including current and recently retired referees.

### **Summary of Significant Accounting Policies**

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Associations Incorporation Act (Qld) 1981. The management committee has determined that the Association is a non-reporting entity and therefore there is no requirement to apply accounting standards and other mandatory professional reporting requirements in the preparation and presentation of these statements.

The statements have been prepared in accordance with the requirements of the Associations Incorporation Act (Qld) 1981. The statements are prepared on a cash basis, whereby items are bought to account as money is paid or received, from the records of the association. These are based on historical costs and do not take into account changing money values or, except where as specifically stated, current valuation of non-current assets.

The accounting policies have been consistently applied, unless otherwise stated. The following is a summary of significant accounting policies adopted by the Queensland Rugby Referees Association (Brisbane) Incorporated in the preparation of the financial statements.

#### (a) Taxation

As of 1 July 2000, the association was registered with the ATO for GST purposes. It is a nonprofit organisation that has voluntarily nominated for GST.

No provision has been made for income tax as the association is exempt from income tax under the provisions of section 23(g) of the Income Tax Assessment Act.

The Association was and still is not required to have a Tax File Number.

The Association collects and pays GST quarterly. A Business Activity Statement (BAS) is submitted to the ATO on a quarterly basis as required by the taxation legislation.

#### (b) Stock on Hand

All bar stock and referee's apparel are expensed in the year of purchase.

#### (c) Equipment

All equipment purchases are expensed in the year of purchase.

For control purposes such items have been listed on the register of non-current assets/chattels.

### (d) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### (e) Revenue

Revenue is measured at the fair value of the consideration received or receivable.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.
