PRESIDENT'S REPORT

This report is my second as President and it comes after another rewarding and challenging year for the QRRA (Brisbane), its members, Committee, and myself.

2021 has been a year of continued challenges and trials for the association and individuals. Fortunately, one thing has not changed, and that is the commitment to service as volunteers by QRRA members, whatever their age, experience, or level of expertise. A great majority of our members, referee because it is an enjoyable pastime which allows us to give back to the community and help instil life values These values are stated by Rugby Australia as Teamwork, Respect, Enjoyment, Discipline and Sportsmanship. Without saying, the opportunity for intentional exercise is a valued benefit is refereeing.

Please let me take this opportunity to thank all members again formally for their commitment in providing the community with a generally enjoyable and well managed pastime.

Sponsorship

QRRA could not exist and achieve its goals as an independent volunteer body without financial support. It is worth remembering that the QRRA is a member of the QRU, not a subsidiary of the QRU.

This season saw the commencement of new sponsorship agreements. The sponsors to come on board were TFH, Glow Health, and Mantle Health. As part of these arrangements, we were pleased to be able to continue our association with Allsports Physiotherapy.

I urge you to promote our sponsors, wherever possible, so their contribution receives the deserved recognition.

On the Field

Resulting from our work with the Rugby Australia referee team, and with our own education, coaching and fitness efforts, it is pleasing to see further success for QRRA referees across a range of levels. Education this year had the Association take on some responsibility to creating sessions that addressed the concerns of our membership. Feedback from our membership is that these sessions were very much appreciated. In addition to our members other Queensland associations were able to join in via Zoom and benefit from education that they have difficulty delivering. Thanks to Ben Dorrington-Plumb and Greg Hinton for co-ordinating members of the Premier Squad to deliver these sessions.

Yes, we have had referees officiate test matches, Super rugby, Super rugby Au, Premier, Suburban, junior club, and schools. Let us not forget the university competitions, sevens and the many community competitions we are asked to officiate at. To this point I would like to thank those members who over several weekends volunteered to referee matches in excess to normal expectations.

COVID

2021 was another year impacted by Covid with several lockdowns impacting competitions. We need to be thankful that as a sport locally we were able to play most of our expected season and have Final Series in the various competitions. The roles that each of you undertook to ensure these matches could happen is appreciated.

Drivers of Success

As an association we do strive to not only provide a service but the best service we can. Whether it be referees appointed to under 10's or through to Premier grade. Or, developing referees for higher appointments such as Super Rugby, International matches or 7s.

There have been two main pillars to achieving this in 2021. Firstly, has been the more regular education sessions for referees. This has already been spoken about in this report.

The second pillar is fitness. The association has engaged Ms Sophie Dodd to co-ordinate the fitness sessions. These sessions have been happening on Monday evenings initially at Easts and then moved to Kelvin Grove State High School. Pleasingly, numbers have of members have taken advantage of this opportunity. Additionally, the Premier Squad had extra training expectations placed on them.

Some 2021 differences to 2020:

2020 had its challenges which were obvious and widely reported. 2021 decided to try and be noticed as well. Thankfully as previously noted although interrupted we did have a more continuous and "normal year". To this there were some improvements from 2020 some of these were:

- New sponsors
- New Uniforms
- Schools' competitions where in the term the were supposed to be in
- Junior referee afternoon was held at Easts. This was an opportunity for information specifically relating to junior refereeing and rugby to be given to referees who attended. You may recall this event was the first casualty of Covid last year as it was to happen on the Sunday that the initial lockdown was called.

Challenges

As in previous years referee abuse has been a concern. The focus of the association is to provide support where we can for our referees if they have been abused. While our focus is supporting our referee, we also work in with competition managers and clubs to ensure that the instigators of abuse are appropriately sanctioned but also as part of the education process aimed at developing respect for all members of the rugby community. 2021 has seen many abuse complaints and now the challenge is not just about having appropriate investigations and sanctions delivered, but also the QRRA receiving communications back so the referee can be assured their complaint was taken seriously and dealt with.

Thanks

To the 2021 Committee, I express my thanks for your teamwork, for your input, guidance, and support in leading the Association. Simon Moore (Vice President), Gert Erasmus (Secretary), Cameron Stanfield (Treasurer) and Committee members Ben Dorrington-Plumb, Michael Kent, Michael Orgill and Lara West.

Further, I thank Administration Officer Nicholas Joseph, Senior Appointments Officer Geoffrey Pegg and Junior Appointments Officer Laurie Monaghan for the endless hours that they put in maintaining the core business of QRRA – communication and referee appointments. Along with these gentlemen Greg Hinton (Senior Referee Coaching Co-ordinator and Premier Manager), Cole Barratt (Junior Referee Coaching Co-ordinator). Let's also not forget our Social Media co-ordinators Charlie Marshall and Lara West.

Our relationship and collaboration with the major organisations that QRRA provides its services to – QRU, BJRU, QSRU, Clubs and the 3 schools associations, including Jeff Miller and his Board, David Hanham, Gaven Head, John Miller, Kim Schuck and Craig Eason, continues in a positive and progressive manner.

APPOINTMENTS OFFICER'S REPORTS

Senior Appointments

The 2021 season was again challenging for us in dealing with Covid/Delta and the introduction of actioning appointments through a new system, Rugby Explorer. As Covid/Delta only had an impact late in the season which required the rescheduling of the finals series, we were again under pressure for the season peak, June – July, when all Schools plus normal competitions were occurring. With Thursday and Friday being night matches, referees appointed to these matches were again utilised on the Saturday, if available. To cover all Saturday fixtures, a number of referees were appointed to early morning games, possibly below their normal level, and then appointed to Schoolboy matches in the afternoon. A further difficulty with appointments was when Brisbane Competition as well as GPS games where scheduled for the Gold Coast or in Toowoomba on the same day. This was a logistical nightmare as referees appointed to these games could not be utilised elsewhere.

The introduction of appointments through Rugby Explorer was unexpected. Being spoilt by the RAS system, Rugby Explorer was still in the introductory form which resulted in being more time consuming as it did not have the functionality that RAS had. Improvements were made throughout the season and further enhancements are required to bring it up to a RAS standard.

The Schoolboy Aged Championships were able to be held in 2021 with the 17-18 year Championships at Sunnybank being resourced by experienced referees and the State Scholarship Holders undertaking AR duties. The 11-12 and 14-15 year championships were held at Banyo on the same weekend with the State Scholarship Holders being appointed as referees and, after a call for assistance to our membership, AR's were resourced from referees able to provide their time during a weekday. I thank these referees very much as they helped make the Championships a successful event. The State Junior Championships were not able to be held in July due to Covid/Delta lockdown and took place in September at the Toowoomba Grammar School. Referees were resourced from across all State Associations and many thanks to these referees and referee coaches who gave their time to ensure the State Championships were a success.

To all those referees who doubled up over Thursday, Friday and Saturday and to those who willingly travelled to the Gold Coast or Toowoomba, some more than once, my thanks and gratitude to all of you. To all referees who kept their unavailability up to date or contacted me regarding their availability, thank you as this makes an Appointments Officer's job a lot easier and less time consuming.

To all Referee Coaches, I extend my thanks for the many appointments that you undertook during the year and for your feedback on the Referee which assisted in their ongoing appointments.

To everyone, thanks for your assistance in 2021 and may 2022 be an enjoyable and successful season for you.

Junior Appointments

The 2021 junior season felt a bit like deja vue with Covid again leaving its imprint on the season, fortunately not to the extent of the previous year. Nevertheless, the lockdown 'interruptions' delivered a truncated season but the positive was we continued the competition through to grand finals. Many thanks to the BJRU for their persistence working with the clubs and government to enable a viable competition to be completed.

As always, appointments were a logistical challenge with more than 50% of referees having time and/or travel limitations, team affiliation and children playing as a restriction to their appointment. This is an Appointments Officers' reality and is only managed with the great assistance of the referee group. However, it does place enormous pressure on appointments particularly when we have the convergence of Saturday school competitions (GPS, AIC and TAS) for a period. The pressure comes with many double ups and on occasions triple games on the one day. For a few referees this crossed over to both Saturday and Sunday appointments, placing both social and physical burden on those referees.

Thank you to all those referees and those who don't normally referee on Sunday who responded to my various requests to back up and/or go to other locations to fulfil appointments. Certainly, without your commitment and support we would have missed games. Next season we must ensure we have a contingency plan to cover referee shortfalls that occur from time to time.

The corollary to this demand pressure is the 'cannibalising' of referee coaches to referee rather than coach. Sometimes appointments could meet both requirements, but the approach is limited and not a good strategy for overall referee development. Clearly, an issue we need to address for next season particularly concerning new referees and their induction into the ranks.

A continuing and disappointing issue remains the poor behaviour from officials and spectators across all age groups. This includes school games. Unfortunately, some of the worst behaviours came from coaches towards our referees. I know we, as an association, have done a lot of work to manage the issue and the process that goes behind complaints. I do believe we need to work in concert with the BJRU to develop a preventative approach particularly with club officials (coaches). It continues to undermine our retention of referees in both the short and long term.

Referee Coaching

The 2021 season was again significantly impacted by the Covid Pandemic with all 15's competitions experiencing cancellations and or adjustments to schedule programs, including Juniors, Schools and Club Competitions. To all Match Officials who, in these uncertain times, tirelessly and often thanklessly contributed your valuable time week on week so our Association could provide its services to the rugby community, I commend you.

While the Covid pandemic has provided some new challenges, the perennial challenges derived from insufficient personnel, both on field match officials and coaching capacity, continue to impact service delivery. During the peak of the season there are many weeks where referees are officiating two and sometimes three games on one day. There is no doubt that demand for match officials, due to increasing demands of the various competitions, is far outpacing supply, not a new issue but one which is at a critical point with an inability to supply match officials for all games a current reality. The recruitment of new members will be vital to the ongoing success of the Association.

Neill McCann in his report last year identified the "perennial" problem with us having insufficient coaches, unfortunately this issue remains an ongoing challenge. This season in the senior competitions we had an uptick in coaching of referees, on the back of some new initiatives, but we are a long way down from where we would like to be. The ongoing lack of coaching resourcing impacts with the onboarding of new referees and it negatively impacts on the up-skilling of referee talent. While there is strong demand from referees to receive coaching, the same cannot be said for a willingness to contribute as a coach. If we are to bridge the gap between supply and demand there needs to be a general mindset shift, if you want coaching you need to contribute by doing some coaching. Undertaking some coaching will also up-skill you and help your own refereeing skills.

This season we refreshed the 'Premier Squad,' opening up the program to all members through an expression of interest at the beginning of the season, following which, a selection process was undertaken. A Premier Group was formed with three sub-categories; the senior group who were the experienced talent; the development group of pathway talent; and a watch group who were those who expressed interest but deemed not yet suitable to the Premier groups. Over the season a number of changes were made with membership of the sub-categories in response to monitoring of performances.

The demands placed on all involved in the Premier groups was significant, both on and off the field and I commend all involved for their significant contributions. Education sessions, initially targeted to the Premier Groups were expanded and modified for the full membership. Thank you to the senior members of the Premier Group who facilitated education sessions which were opened up and of value to all Associations across Queensland and the Northern Territory. It is intended that these educations sessions will continue in 2022, in addition an online repository will be established as a library for reference.

To support our senior Premier and pathway talent this season we engaged the support of a number of highly skilled and world class match official coaches from both interstate and overseas. The addition of the coaching support added much needed supply as well as world class standard of coaching to help with development of our match officials. In time it is envisaged that our pathway coaching talent will also benefit from the mentorship available to them.

In the lead up to and throughout season 2022 it is intended to expand on the pilot programs we deployed in 2021 with general up-skilling of rugby knowledge. There has been considerable buy-in and support from clubs and team coaches who have been generous with their time and making

available their training sessions to referees seeking to gain game understanding from a team play perspective. The relationship between teams and match officials is strengthening and a number of clubs have expressed interest in having their top end players undertake referee programs and become active match officials, in particular junior games.

There are numerous people who have contributed significantly to the senior coaching and Premier groups during 2021, thank you to all for your efforts. In particular thank you to Geoff Pegg for his guidance and invaluable support throughout the season.

In summary, we need more members to become active referee coaches, if you want coaching you need to do some coaching. If you would like to contribute with coaching please do not hesitate to reach out and express your interest.

Summary of Significant Accounting Policies

These financial statements are a special purpose financial report prepared in order to provide accounts which satisfy the requirements of the Associations Incorporation Act (Qld) 1981. The management committee has determined that the Association is a non-reporting entity and therefore there is no requirement to apply accounting standards and other mandatory professional reporting requirements in the preparation and presentation of these statements.

The statements have been prepared in accordance with the requirements of the Associations Incorporation Act (Qld) 1981. The statements are prepared on a cash basis, whereby items are bought to account as money is paid or received, from the records of the association. These are based on historical costs and do not take into account changing money values or, except where as specifically stated, current valuation of non-current assets.

The accounting policies have been consistently applied, unless otherwise stated. The following is a summary of significant accounting policies adopted by the Queensland Rugby Referees Association (Brisbane) Incorporated in the preparation of the financial statements.

a) Taxation

As of 1 July 2000, the association was registered with ATO for GST purposes. It is a non-profit organisation that has voluntarily nominated for GST.

No provision has been made for income tax as the association is exempt from income tax under the provisions of section 23(g) of the Income Tax Assessment Act.

The Association was and still is not required to have a Tax File Number.

The Association collects and pays GST quarterly. A Business Activity Statement (BAS) is submitted to the ATO on a quarterly basis as required by the taxation legislation.

b) Stock on Hand

All stock and referee's apparel are expensed in the year of purchase.

c) Equipment

All equipment purchases are expensed in the year of purchase.

For control purposes such items have been listed on the register of non-current assets/chattels.

d) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

e) Revenue

Revenue is measured at the fair value of the consideration received or receivable.

Interest revenue is recognised using the effective interest rate method, for which floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.
